# ZAPPA-SZÉP PRODUCTS FOR PARTIAL ACTIONS OF GROUPOIDS ON LEFT CANCELLATIVE SMALL CATEGORIES.

#### EDUARD ORTEGA AND ENRIQUE PARDO

ABSTRACT. We study groupoid actions on left cancellative small categories and their associated Zappa-Szép products. We show that certain left cancellative small categories with nice length functions can be seen as Zappa-Szép products. We compute the associated tight groupoids, characterizing important properties of them, like being Hausdorff, effective and minimal. Finally, we determine amenability of the tight groupoid under mild, reasonable hypotheses.

## INTRODUCTION

In [18], Spielberg described a new method of defining  $C^*$ -algebras associated to oriented combinatorial data, generalizing the construction of algebras from directed graphs, higher-rank graphs, and (quasi-)ordered groups. To this end, he introduced categories of paths –i.e. cancellative small categories with no (nontrivial) inverses– as a generalization of higher rank graphs, as well as ordered groups. The idea is to start with a suitable combinatorial object and define a  $C^*$ -algebra directly from what might be termed the generalized symbolic dynamics that it induces. Associated to the underlying symbolic dynamics, he presents a natural groupoid derived from this structure. The construction also gives rise to a presentation by generators and relations, tightly related to the groupoid presentation. In [19] he showed that most of the results hold when relaxing the conditions, so that right cancellation or having no (nontrivial) inverses are taken out of the picture.

In [15], the authors studied Spielberg's construction, using a groupoid approach based in the Exel's tight groupoid construction [6], showing that the tight groupoid for these inverse semigroups coincide with Spielberg's groupoid [17]. With this tool at hand, they were able to characterize simplicity for the algebras associated to finitely aligned left cancellative small categories, and in particular in the case of Exel-Pardo systems [8]. Finally, they gave, under mild and necessary hypotheses, a characterization of amenability for such a groupoid.

Therefore, it becomes important to understand the internal structure of the left cancellative small category to check the desired properties of the associated groupoid, and

hence of its associated  $(C^*$ -)algebra. A classical idea is to decompose our complex object in different simple pieces with well-behaved relations between them. This was well studied in [13, 12], where it was proved that categories with length functions on  $\mathbb{N}^k$  with certain decomposition properties can be written as the Zappa-Szép product of the groupoid of invertible elements of the category and a higher-rank graph subcategory generated by a transversal of generators of maximal right ideals. Zappa-Szép products of left cancellative small categories and groups were studied by Bédos, Kaliszewski, Quigg and Spielberg in [2], where they studied the representation theory for the Spielberg algebras of the new left cancellative small category associated to this construction.

In the present paper, we extend the scope of [2] to actions of groupoids, To this end, we define groupoid actions on a left cancellative small category and their Zappa-Szép products, and we show that Zappa-Szép products appear naturally in the context of left cancellative small categories with length functions. Finally, we will extend the results of [15, Sections 7 & 8] to determine the essential properties of the tight groupoid associated to Zappa-Szép products of groupoid actions on a left cancellative small category, including the amenability of its tight groupoid.

The contents of this paper can be summarized as follows: In Section 1 we recall some known results on small categories, and we define length functions and factorization properties we will need in the sequel. In Section 2 we define groupoid actions on left cancellative small categories. In Section 3 we define the Zappa-Szép products of certain groupoid actions on left cancellative small categories. In Section 4 we show that left cancellative small categories with nice length functions can be described as Zappa-Szép products of the action of their groupoid of invertible elements on certain nice subcategories. In Section 5 we analyze the structure of the tight groupoid associated to Zappa-Szép products of groupoid actions to left cancellative small categories. We close the paper studying, in Section 6, the amenability of the tight groupoid of this kind of Zappa-Szép products.

#### 1. Small categories.

In this section we collect all the basic background material about small categories we need for the rest of the paper. For more details see [15].

Given a small category  $\Lambda$ , we will denote by  $\Lambda^{\circ}$  its objects, and we will identify  $\Lambda^{\circ}$  with the identity morphisms, so that  $\Lambda^{\circ} \subseteq \Lambda$ . Given  $\alpha \in \Lambda$ , we will denote by  $s(\alpha) := \operatorname{dom}(\alpha) \in \Lambda^{\circ}$  and  $r(\alpha) := \operatorname{ran}(\alpha) \in \Lambda^{\circ}$ . The right invertible elements of  $\Lambda$  are

$$\Lambda^{-1} := \{ \alpha \in \Lambda : \exists \beta \in \Lambda \text{ such that } \alpha \beta = s(\beta) \}.$$

**Definition 1.1.** Given a small category  $\Lambda$ , and let  $\alpha, \beta, \gamma \in \Lambda$ :

- (1)  $\Lambda$  is left cancellative if  $\alpha\beta = \alpha\gamma$  then  $\beta = \gamma$ ,
- (2)  $\Lambda$  is right cancellative if  $\beta \alpha = \gamma \alpha$  then  $\beta = \gamma$ ,
- (3)  $\Lambda$  has no inverses if  $\alpha\beta = s(\beta)$  then  $\alpha = \beta = s(\beta)$ .

A *category of paths* is a small category that is right and left cancellative and has no inverses.

Notice that if  $\Lambda$  is either left or right cancellative, then the only idempotents in  $\Lambda$  are  $\Lambda^{\circ}$ . Therefore, given  $\alpha \in \Lambda^{-1}$  with right inverse  $\beta$ , we have that  $\beta \alpha = s(\alpha)$ . Thus,  $\Lambda^{-1}$ 

is the set of the right and left invertible morphisms. Given  $\alpha \in \Lambda^{-1}$  we will denote by  $\alpha^{-1}$  its inverse.

**Definition 1.2.** Let  $\Lambda$  be a small category. Given  $\alpha, \beta \in \Lambda$ , we say that  $\beta$  extends  $\alpha$  (equivalently  $\alpha$  is an initial segments of  $\beta$ ) if there exists  $\gamma \in \Lambda$  such that  $\beta = \alpha \gamma$ . We denote by  $[\beta] = \{\alpha \in \Lambda : \alpha \text{ is an initial segment of } \beta\}$ . We write  $\alpha \leq \beta$  if  $\alpha \in [\beta]$ .

Let  $\Lambda$  be a left cancellative small category. Then given  $\alpha, \beta \in \Lambda$ , then the following is equivalent

- (1)  $\alpha \leq \beta$  and  $\beta \leq \alpha \ (\alpha \approx \beta)$ ,
- (2)  $\beta \in \alpha \Lambda^{-1}$
- (3)  $\alpha \in \beta \Lambda^{-1}$ ,
- (4)  $\alpha \Lambda = \beta \Lambda$ ,
- (5)  $[\alpha] = [\beta].$

**Notation 1.3.** Let  $\Lambda$  be a left cancellative small category. Given  $\alpha, \beta \in \Lambda$ , we say :

- (1)  $\alpha \cap \beta$  if and only if  $\alpha \Lambda \cap \beta \Lambda \neq \emptyset$ ,
- (2)  $\alpha \perp \beta$  if and only if  $\alpha \Lambda \cap \beta \Lambda = \emptyset$ .

**Definition 1.4.** Let  $\Lambda$  be a left cancellative small category, and let  $F \subset \Lambda$ . The elements of  $\bigcap_{\gamma \in F} \gamma \Lambda$  are the common extensions of F. A common extension  $\varepsilon$  of F is minimal if

for any common extension  $\gamma$  with  $\varepsilon \in \gamma \Lambda$  we have that  $\gamma \approx \varepsilon$ .

When  $\Lambda$  has no inverses, given  $F \subseteq \Lambda$  and given any minimal common extension  $\varepsilon$  of F, if  $\gamma$  is common extension of F with  $\varepsilon \in \gamma \Lambda$  then  $\gamma = \varepsilon$ . We will denote by

 $\alpha \lor \beta := \{ \text{the minimal extensions of } \alpha \text{ and } \beta \}.$ 

Notice that if  $\alpha \lor \beta \neq \emptyset$  then  $\alpha \cap \beta$ , but the converse fails in general.

**Definition 1.5.** A left cancellative small category  $\Lambda$  is *finitely aligned* if for every  $\alpha, \beta \in \Lambda$  there exists a finite subset  $\Gamma \subset \Lambda$  such that  $\alpha \Lambda \cap \beta \Lambda = \bigcup_{\alpha \in \Gamma} \gamma \Lambda$ .

When  $\Lambda$  is a finitely aligned left cancellative small category, we can always assume that  $\alpha \lor \beta = \Gamma$  where  $\Gamma$  is a finite set of minimal common extensions of  $\alpha$  and  $\beta$ .

**Definition 1.6.** Let  $\Lambda$  be a LCSC and  $\alpha \in \Lambda$ . A subset  $F \subset r(\alpha)\Lambda$  is *exhaustive with* respect to  $\alpha$  if for every  $\gamma \in \alpha\Lambda$  there exists a  $\beta \in F$  with  $\beta \cap \gamma$ . We denote  $\mathsf{FE}(\alpha)$  the collection of finite sets of  $r(\alpha)\Lambda$  that are exhaustive with respect to  $\alpha$ .

**Definition 1.7.** Let  $\Lambda$  be a LCSC and let  $\Gamma \subseteq Q$  be a submonoid of a group Q with unit element  $\mathbf{1}_Q$ , and such that  $\Gamma \cap \Gamma^{-1} = {\mathbf{1}_Q}$ . A map  $\mathbf{d} : \Lambda \to \Gamma$  is called a *length function* if

(1)  $\mathbf{d}(\alpha\beta) = \mathbf{d}(\alpha)\mathbf{d}(\beta)$  for every  $\alpha, \beta \in \Lambda$  with  $s(\alpha) = r(\beta)$ ,

A length function is say to satisfy the *weak factorization property* if

**(WFP)** for every  $\alpha \in \Lambda$  and  $\gamma_1, \gamma_2 \in \Gamma$  with  $\mathbf{d}(\alpha) = \gamma_1 \gamma_2$ , there are  $\alpha_1, \alpha_2 \in \Lambda$  with  $s(\alpha_1) = r(\alpha_2)$ ,  $\mathbf{d}(\alpha_i) = \gamma_i$  for i = 1, 2, such that  $\alpha = \alpha_1 \alpha_2$ , and moreover for every  $\beta_1, \beta_2 \in \Lambda$  with  $s(\beta_1) = r(\beta_2)$ ,  $\mathbf{d}(\beta_i) = \gamma_i$  for i = 1, 2, such that  $\alpha = \beta_1 \beta_2$ , there exists  $g_1, g_2 \in \Lambda^{-1}$  such that  $\beta_1 = \alpha_1 g_1$  and  $\beta_2 = g_2 \alpha_2$ .

Observe that, given a LCSC  $\Lambda$ , always exists what we will call the *trivial length* function  $\mathbf{d} : \Lambda \to \Gamma$ , defined by  $\mathbf{d}(\alpha) = \mathbf{1}_Q$  for every  $\alpha \in \Lambda$ .

The above definition is motivated by the one given in [12, Section 3] where there the authors only consider the case when  $\Gamma = \mathbb{N}^k$ .

We recall that a length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfies the unique factorization property **(UFP)** if for every  $\alpha \in \Lambda$  and  $\gamma_1, \gamma_2 \in \Gamma$  with  $\mathbf{d}(\alpha) = \gamma_1 \gamma_2$ , there are unique  $\alpha_1, \alpha_2 \in \Lambda$  with  $\alpha = \alpha_1 \alpha_2$  and  $\mathbf{d}(\alpha_i) = \gamma_i$  for i = 1, 2 [16, Definition 6.1].

**Remarks 1.8.** Let  $\Lambda$  be a LCSC and let  $\Gamma \subseteq Q$  be a submonoid of a group Q with unit element  $\mathbf{1}_Q$ , and such that  $\Gamma \cap \Gamma^{-1} = {\mathbf{1}_Q}$ . Then, given a length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP, we have:

(1)  $\mathbf{d}^{-1}(\mathbf{1}_Q) = \Lambda^{-1}$ . Indeed, first observe that, given  $v \in \Lambda^0$ , we have that  $\mathbf{d}(v) = \mathbf{d}(vv) = \mathbf{d}(v)\mathbf{d}(v)$ , and hence  $\mathbf{d}(v) = \mathbf{1}_Q$ . Now, let  $g \in \Lambda^{-1}$ . Then

$$\mathbf{1}_Q = \mathbf{d}(s(g)) = \mathbf{d}(g^{-1}g) = \mathbf{d}(g^{-1})\mathbf{d}(g).$$

Therefore,  $\mathbf{d}(g^{-1}) = \mathbf{d}(g)^{-1}$ , whence  $\mathbf{d}(g) = \mathbf{1}_Q$ . Now, let  $\alpha \in \Lambda$  such that  $\mathbf{d}(\alpha) = \mathbf{1}_Q$ . Since  $\alpha = \alpha s(\alpha) = r(\alpha)\alpha$ , we have that  $\mathbf{d}(\alpha s(\alpha)) = \mathbf{1}_Q \mathbf{1}_Q = \mathbf{d}(r(\alpha)\alpha)$ . By the WFP, there exists  $g_1, g_2 \in \Lambda^{-1}$  such that  $\alpha = r(\alpha)g_1$  and  $s(\alpha) = g_2\alpha$ . Thus,  $\alpha = g_1 \in \Lambda^{-1}$ .

(2)  $\mathbf{d} : \Lambda \to \Gamma$  satisfies the UFP if and only if it satisfies the WFP and  $\Lambda$  has no inverses.

**Definition 1.9.** A LCSC  $\Lambda$  is called *action-free* if the action of  $\Lambda^{-1}$  on  $\Lambda$  is free; that is, whenever  $g\gamma = \gamma$  for some  $\gamma \in \Lambda$  and  $g \in \Lambda^{-1}$ , then  $g = r(\gamma)$ .

Observe that if  $\Lambda$  has no inverses, then  $\Lambda$  is action-free.

**Lemma 1.10.** Let  $\Lambda$  be a LCSC and let  $\mathbf{d} : \Lambda \to \Gamma$  be a length function satisfying the WFP. Then  $\Lambda$  is right cancellative if and only if  $\Lambda$  is action-free.

Proof. Suppose that  $\Lambda$  is action-free. Let  $\alpha, \beta, \gamma \in \Lambda$  with  $\alpha \gamma = \beta \gamma$ . Applying the WFP we see that there exists  $g_1, g_2 \in \Lambda^{-1}$  with  $\beta = \alpha g_1$  and  $\gamma = g_2 \gamma$ . Therefore,  $\alpha \gamma = \alpha g_1 g_2 \gamma$ , so  $\gamma = g_1 g_2 \gamma$  by left cancellation and  $g_1 g_2 = r(\gamma)$  by action-freeness. Hence  $g_2 = g_1^{-1}$ . Finally we have that  $g_1^{-1} \gamma = \gamma$ , and using action-freeness again we have that  $g_1^{-1} = r(\gamma)$  and so  $\beta = \alpha$ . The converse is straightforward.

**Definition 1.11.** A groupoid is a small category such that every morphism has an inverse. Given a groupoid  $\mathcal{G}$  we denote by  $\mathcal{G}^{(0)}$  the set of identity functions on its objects (units of  $\mathcal{G}$ ). Moreover, we define the range and source functions  $r : \mathcal{G} \to \mathcal{G}^{(0)}$  and  $s : \mathcal{G} \to \mathcal{G}^{(0)}$  by  $r(g) = gg^{-1}$  and  $s(g) = g^{-1}g$  for every  $g \in \mathcal{G}$ . We denote by  $\mathcal{G}^{(2)} := \{(g, h) \in \mathcal{G} \times \mathcal{G} : s(g) = r(h)\}$  the set of composable morphisms. A topological groupoid is a groupoid with a topology that makes the product and inverse operations continuous. A discrete groupoid is a topological groupoid with the discrete topology.

**Example 1.12.** Given a LCSC  $\Lambda$ ,  $\Lambda^{-1}$  is a (discrete) groupoid where we can identify  $(\Lambda^{-1})^{(0)}$  with  $\Lambda^{0}$ .

#### 2. Groupoid partial actions

In this section, we will define actions of groupoids on left cancellative small categories. This is inspired in the construction of partial actions of groupoids on graphs [9, Sections 2 & 3].

For the rest of the paper we will assume that  $\Gamma \subseteq Q$  is a submonoid of a group Q with unit element  $\mathbf{1}_Q$  such that  $\Gamma \cap \Gamma^{-1} = {\mathbf{1}_Q}$ .

The first step is to define the notion of partial isomorphism of a small category  $\Lambda$  inspired in [9, Definition 3.1].

**Definition 2.1.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ . Let  $\text{PIso}(\Lambda, \mathbf{d})$  be the set of partial isomorphisms of  $\Lambda$ ,  $f \in \text{PIso}(\Lambda, \mathbf{d})$  such that satisfies:

- (1)  $f: v\Lambda \to w\Lambda$  is a bijection for some  $v, w \in \Lambda^0$ ,
- (2)  $f(\alpha \Lambda) = f(\alpha)\Lambda$  for every  $\alpha \in v\Lambda$ .
- (3) f(v) = w,
- (4)  $\mathbf{d}(f(\alpha)) = \mathbf{d}(\alpha)$  for every  $\alpha \in v\Lambda$ .

We will denote by v =: d(f) (the domain of f) and by w =: c(f) (the codomain of f).

# Remark 2.2.

- (1) Observe that condition (3) does not follow from the previous conditions. Indeed, given  $g \in \Lambda^{-1}$ , the map  $f : s(g)\Lambda \to r(g)\Lambda$  given by  $f(\gamma) = g\gamma$  for every  $\gamma \in s(g)\Lambda$  satisfies conditions (1) (2) but not (3) whenever  $g \in \Lambda^{-1} \setminus \Lambda^0$ .
- (2) Given  $f: v\Lambda \to w\Lambda$  in  $\operatorname{PIso}(\Lambda, \mathbf{d})$  and  $g \in v\Lambda^{-1}$  we have that  $f(gg^{-1}) = w$  by condition (3), and hence by condition (2) there exists  $h \in \Lambda$  such that f(g)h = w, so  $f(g) \in \Lambda^{-1}$ .

**Lemma 2.3.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ . Then, given  $f \in PIso(\Lambda, \mathbf{d})$  and  $\alpha \in d(f)\Lambda$ , there exists a unique function  $f_{|\alpha} : s(\alpha)\Lambda \to s(f(\alpha))\Lambda$  in  $PIso(\Lambda, \mathbf{d})$  such that  $f(\alpha\beta) = f(\alpha)f_{|\alpha}(\beta)$  for every  $\beta \in s(\alpha)\Lambda$ .

*Proof.* Given  $f \in \text{PIso}(\Lambda, \mathbf{d})$  and  $\alpha \in d(f)\Lambda$  we define

$$\begin{array}{rccc} f_{\mid \alpha} : & s(\alpha)\Lambda & \to & s(f(\alpha))\Lambda \\ & \beta & \mapsto & \gamma \end{array}$$

where  $\gamma \in s(f(\alpha))\Lambda$  is such that  $f(\alpha\beta) = f(\alpha)\gamma$ . The existence of  $\gamma$  is guaranteed by condition (2). Now suppose that there exist  $\gamma_1, \gamma_2 \in s(f(\alpha))\Lambda$  such that  $f(\alpha\beta) = f(\alpha)\gamma_1 = f(\alpha)\gamma_1$ . Then, by left cancellation, we have that  $\gamma_1 = \gamma_2$ , so  $f_{|\alpha|}$  is well-defined.

Now suppose there exist  $\beta_1, \beta_2 \in s(\alpha)\Lambda$  that satisfy  $f(\alpha)\gamma = f(\alpha\beta_1) = f(\alpha\beta_2)$  for some  $\gamma \in s(f(\alpha))\Lambda$ . Since f is bijective,  $\alpha\beta_1 = \alpha\beta_2$ , whence  $\beta_1 = \beta_2$  by left cancellation. Thus,  $f_{|\alpha}$  is injective. Finally, if  $\gamma \in s(f(\alpha))\Lambda$ , then  $f(\alpha)\gamma \in f(\alpha)\Lambda = f(\alpha\Lambda)$ , so that there exists  $\beta \in s(\alpha)\Lambda$  such that  $f(\alpha\beta) = f(\alpha)\gamma$ . Thus,  $f_{|\alpha}(\beta) = \gamma$ , whence  $f_{|\alpha}$  is onto, as desired.

Now let  $\beta \in s(\alpha)\Lambda$  and let  $\delta \in s(\beta)\Lambda$ . Then  $f(\alpha\beta\delta) = f(\alpha\beta)f_{|\alpha\beta}(\delta) = f(\alpha)f_{|\alpha}(\beta\delta)$ . On the other hand,  $f(\alpha\beta) = f(\alpha)f_{|\alpha}(\beta)$ , whence  $f(\alpha)f_{|\alpha}(\beta\delta) = f(\alpha)f_{|\alpha}(\beta)f_{|\alpha\beta}(\delta)$ . By left cancellation,  $f_{|\alpha}(\beta\delta) = f_{|\alpha}(\beta)f_{|\alpha\beta}(\delta)$ . Thus,  $f_{|\alpha}$  satisfies condition (2). Also,  $f_{|\alpha}$  is such that  $f(\alpha) = f(\alpha s(\alpha)) = f(\alpha)f_{|\alpha}(s(\alpha))$ , and again by left cancellation  $f_{|\alpha}(s(\alpha)) = s(f(\alpha))$ , so condition (3) is fulfilled. Finally

$$\mathbf{d}(\alpha)\mathbf{d}(\beta) = \mathbf{d}(\alpha\beta) = \mathbf{d}(f(\alpha\beta)) = \mathbf{d}(f(\alpha)f_{|\alpha}(\beta)) = \mathbf{d}(f(\alpha))\mathbf{d}(f_{|\alpha}(\beta)) = \mathbf{d}(\alpha)\mathbf{d}(f_{|\alpha}(\beta))$$

for every  $\beta \in s(\alpha)\Lambda$ . Thus,  $\mathbf{d}(\beta) = \mathbf{d}(f_{|\alpha}(\beta))$  for every  $\beta \in s(\alpha)\Lambda$ , so condition (4) is satisfied.

**Lemma 2.4.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ . Then, given  $\alpha, \beta \in \Lambda$  with  $s(\alpha) = r(\beta)$  and  $f \in PIso(\Lambda, \mathbf{d})$  with  $r(\alpha) = d(f)$ , we have that:

(1)  $f_{|d(f)} = f$ , (2)  $s(f(\alpha)) = f_{|\alpha}(s(\alpha)) = c(f_{|\alpha})$ , (3)  $id_{s(\alpha)} = (id_{r(\alpha)})_{|\alpha}$ , (4)  $f_{|\alpha\beta} = (f_{|\alpha})_{|\beta}$ ,

*Proof.* (1) – (3) are straightforward by the definition. To prove (4), let  $\alpha, \beta, \gamma \in \Lambda$  with  $s(\alpha) = r(\beta)$  and  $s(\beta) = r(\gamma)$ , and let  $f \in \text{PIso}(\Lambda, \mathbf{d})$  with  $r(\alpha) = d(f)$ . Then

$$f(\alpha\beta\gamma) = f(\alpha)f_{|\alpha}(\beta\gamma) = f(\alpha)f_{|\alpha}(\beta)(f_{|\alpha})_{|\beta}(\gamma),$$

and on the other hand

$$f(\alpha\beta\gamma) = f(\alpha\beta)f_{|\alpha\beta}(\gamma) = f(\alpha)f_{|\alpha}(\beta)f_{|\alpha\beta}(\gamma) \,.$$

By left cancellation of  $\Lambda$ , we have that  $(f_{|\alpha})_{|\beta}(\gamma) = f_{|\alpha\beta}(\gamma)$ . Since this equality holds for every  $\alpha \in s(\beta)\Lambda$ , it follows that  $f_{|\alpha\beta} = (f_{|\alpha})_{|\beta}$ .

Next step is to show that  $PIso(\Lambda, \mathbf{d})$  has a natural groupoid structure.

**Lemma 2.5.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ . Then, given  $f, g \in PIso(\Lambda, \mathbf{d})$  such that d(f) = c(g), the composition  $f \circ g \in PIso(\Lambda, \mathbf{d})$ .

Proof. Given  $f, g \in \text{PIso}(\Lambda, \mathbf{d})$  such that d(f) = c(g), we have that  $(f \circ g) : d(g)\Lambda \to c(f)\Lambda$  is given by  $f(g(\alpha))$  for every  $\alpha \in d(g)\Lambda$ . Clearly,  $f \circ g$  is a bijection and  $(f \circ g)(d(g)) = c(f)$ . It remains to check that  $f \circ g$  satisfies condition (2). Let  $\alpha \in d(g)\Lambda$  and  $\beta \in s(\alpha)\Lambda$ . Then  $(f \circ g)(\alpha\beta) = f(g(\alpha\beta)) = f(g(\alpha)g_{|\alpha}(\beta)) = f(g(\alpha))f_{|g(\alpha)}(g_{|\alpha}(\beta)) = (f \circ g)(\alpha)f_{|g(\alpha)}(g_{|\alpha}(\beta))$ . Since by Lemma 2.3 the maps  $g_{|\alpha}$  and  $f_{|g(\alpha)}$  are surjective it follows that  $(f \circ g)(\alpha\Lambda) = (f \circ g)(\alpha)\Lambda$ , as desired. Finally, given  $\alpha \in d(g)\Lambda$  then  $\mathbf{d}((f \circ g)(\alpha)) = \mathbf{d}(f(g(\alpha))) = \mathbf{d}(g(\alpha)) = \mathbf{d}(\alpha)$ , so condition (4) is satisfied.

For each  $v \in \Lambda^0$ , we define  $\mathrm{id}_v : v\Lambda \to v\Lambda$  to be the identity map on  $v\Lambda$ , so that  $\mathrm{id}_v \in \mathrm{PIso}(\Lambda, \mathbf{d})$ 

**Lemma 2.6.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , and let  $f \in PIso(\Lambda, \mathbf{d})$ . Then  $f^{-1} \in PIso(\Lambda, \mathbf{d})$ .

Proof. If  $f \in \operatorname{PIso}(\Lambda)$ , then  $f^{-1} : c(f)\Lambda \to d(f)\Lambda$  is the unique function such that  $(f^{-1} \circ f) = \operatorname{id}_{d(f)}$  and  $(f \circ f^{-1}) = \operatorname{id}_{c(f)}$ . Clearly,  $f^{-1}$  satisfies conditions (1), (3) and (4). Let  $\alpha \in c(f)\Lambda$ , and  $\beta \in s(\alpha)\Lambda$ . Then  $f^{-1}(\alpha\beta) = f^{-1}(f(f^{-1}(\alpha))\beta)$ , but since  $f(f^{-1}(\alpha)\Lambda) = f(f^{-1}(\alpha))\Lambda = \alpha\Lambda$  and f is bijective, it follows that there exists a unique  $\gamma \in s(f^{-1}(\alpha))\Lambda$  such that  $\alpha\beta = f(f^{-1}(\alpha))\beta = f(f^{-1}(\alpha)\gamma)$ . Therefore,  $f^{-1}(\alpha\beta) = f^{-1}(f(f^{-1}(\alpha)\gamma)) = f^{-1}(\alpha)\gamma$ . Moreover since for every  $\gamma \in s(f^{-1}(\alpha))\Lambda$  there exists  $\beta \in s(\alpha)\Lambda$  such that  $\alpha\beta = f(f^{-1}(\alpha)\gamma)$ , it follows that  $f^{-1}(\alpha\Lambda) = f^{-1}(\alpha)\Lambda$ .

Now, using Lemmas 2.5 & 2.6, we can define a groupoid structure in  $PIso(\Lambda, \mathbf{d})$ .

**Definition 2.7.** If  $\Lambda$  is a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , then  $\operatorname{PIso}(\Lambda, \mathbf{d})$  is a discrete groupoid, where given  $f, g \in \operatorname{PIso}(\Lambda, \mathbf{d})$  the product fg is defined as the composition  $f \circ g$  whenever d(f) = c(g), and  $f^{-1}$  is the set-theoretical inverse of f. Moreover, we can identify unit space of  $(\operatorname{PIso}(\Lambda, \mathbf{d}))^{(0)} = {\operatorname{id}_v : v \in \Lambda^0}$  with  $\Lambda^0$ .

With this in mind, we can define the notion of action of a groupoid on a LCSC that we need.

**Definition 2.8.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , and let  $\mathcal{G}$  be a discrete groupoid. An action of  $\mathcal{G}$  on  $\Lambda$  is a groupoid homomorphism  $\phi : \mathcal{G} \to \text{PIso}(\Lambda, \mathbf{d})$ . Given  $g \in \mathcal{G}$  and  $\alpha \in d(\phi(g))\Lambda$ , we write the action of g on  $\alpha$  by  $g \cdot \alpha := \phi(g)(\alpha)$ .

Using the identification  $(\operatorname{PIso}(\Lambda, \mathbf{d}))^{(0)} = \Lambda^0$ , so that  $\phi(\mathcal{G}^{(0)}) \subseteq \Lambda^0$ , and that  $\phi(s(g)) = d(\phi(g))$  and  $\phi(r(g)) = c(\phi(g))$  for any  $g \in \mathcal{G}$ , we have that

$$\phi(g):\phi(s(g))\Lambda \to \phi(r(g))\Lambda$$

**Remarks 2.9.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , and let  $\phi : \mathcal{G} \to \text{PIso}(\Lambda, \mathbf{d})$  be a groupoid action on  $\Lambda$ . Then:

(1) Suppose that  $\Delta^0 := \phi(\mathcal{G}^{(0)}) \subsetneqq \Lambda^0$ . Let us define

$$\Delta := \{ \alpha \in \Lambda; s(\alpha), r(\alpha) \in \Delta^0 \}.$$

Then  $\Delta$  is a LCSC, and  $\phi(\mathcal{G}) \subseteq \operatorname{PIso}(\Delta, \mathbf{d})$ . However  $\Delta$  is not necessarily finitely aligned if so is  $\Lambda$ . Thus, such a restriction will affect the arguments. Hence, we will always assume that, given an action of  $\mathcal{G}$  on  $\Lambda$ , either  $\phi(\mathcal{G}^{(0)}) = \Lambda^0$ , or that the restricted subcategory  $\Delta$  inherits the finitely aligned property. In practice, that means that, after restricting if necessary, we will assume that  $\phi(\mathcal{G}^{(0)}) = \Lambda^0$ .

(2) Suppose that  $\phi_{|\mathcal{G}^{(0)}}$  is not an injective map. Then it can happen that there exists  $(g,h) \notin \mathcal{G}^{(2)}$ , that is  $s(g) \neq r(h)$ , but  $(\phi(g), \phi(h)) \in (\operatorname{PIso}(\Lambda, \mathbf{d}))^{(2)}$ , that is  $\phi(s(g)) = d(\phi(g)) = c(\phi(h)) = \phi(r(h))$ , and hence  $\phi(g)\phi(h) \in \operatorname{PIso}(\Lambda, \mathbf{d}) \setminus \phi(\mathcal{G})$ . This will affect defining composability of elements in the corresponding Zappa-Szép product. Since our model should include non-faithful self-similar actions of a groupoid  $\mathcal{G}$  on  $\Lambda$ , we cannot skip that case. Then, for a non-injective action, we will need to include the condition that for every  $g, h \in \mathcal{G}$ , then s(g) = r(h) if and only if  $d(\phi(g)) = \phi(s(g)) = \phi(r(h)) = c(\phi(h))$ , or equivalently, that  $\phi_{|\mathcal{G}^{(0)}}$  is injective.

According to Remarks 2.9, we will assume during the whole paper that an action of a discrete groupoid  $\mathcal{G}$  on a small category  $\Lambda$  through a (not necessarily injective) groupoid homomorphism  $\phi : \mathcal{G} \to \operatorname{PIso}(\Lambda, \mathbf{d})$ , satisfies that  $\phi_{|\mathcal{G}^{(0)}|}$  is a bijection. Therefore we will identify  $\mathcal{G}^{(0)} = \Lambda^{(0)} = \operatorname{PIso}(\Lambda, \mathbf{d})^{(0)}$  omitting  $\phi$ .

#### 3. Zappa-Szép products for groupoid actions

In this section, we will define the Zappa-Szép product of a left cancellative small category. This is inspired in the construction of the Zappa-Szép product of a groupoid on a finite graph [9, Section 3] and the Zappa-Szép product of a group acting on a left

cancellative small category [3, 15]. This has also been recently done in [12] where they construct Zappa-Szép products of groupoids acting on higher-rank graphs.

First, we will state the abstract notion of self-similar action, in order to boil up the exact definition of 1-cocycle we will need.

**Definition 3.1.** Let  $\mathcal{G}$  be a discrete groupoid acting on a LCSC  $\Lambda$  with length function  $\mathbf{d} : \Lambda \to \Gamma$ . We say that the action is *self-similar* if for every  $g \in \mathcal{G}$  and for every  $\alpha \in s(g)\Lambda$  there exists  $h \in \mathcal{G}$  such that

$$g \cdot (\alpha \mu) = (g \cdot \alpha)(h \cdot \mu)$$

for every  $\mu \in s(\alpha)\Lambda$ .

Clearly, in the above definition h depends on g and  $\alpha$ . A natural question is to decide whether such an h is unique. Suppose that  $h_1, h_2 \in \mathcal{G}$  satisfy  $g \cdot (\alpha \mu) = (g \cdot \alpha)(h_i \cdot \mu)$ (i = 1, 2) for every  $\mu \in s(\alpha)\Lambda$ . Then

$$(g \cdot \alpha)(h_1 \cdot \mu) = (g \cdot \alpha)(h_2 \cdot \mu)$$

Since  $\Lambda$  is left cancellative, then

$$(h_1 \cdot \mu) = (h_2 \cdot \mu)$$

for every  $\mu \in s(\alpha)\Lambda$ . Hence, we can only guarantee that  $\phi(h_1) = \phi(h_2)$ , and  $h_1 = h_2$  only holds when  $\phi$  is injective. We will use this fact to define a suitable notion of cocycle

for such an action. We will essentially follow [2, Section 4], taking care of the fact that the action is partial.

**Definition 3.2.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , and let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ . Consider the set

$$\mathcal{G}_s \times_r \Lambda := \{(g, \alpha) \in \mathcal{G} \times \Lambda : s(g) = r(\alpha)\}.$$

A (partial) cocycle of the action of  $\mathcal{G}$  on  $\Lambda$  is a function  $\varphi : \mathcal{G}_s \times_r \Lambda \to \mathcal{G}$  satisfying the cocycle identity

$$\varphi(gh,\alpha) = \varphi(g,h\cdot\alpha)\varphi(h,\alpha)$$

for any  $(g,h) \in \mathcal{G}^{(2)}$  and any  $\alpha \in \Lambda$  such that  $s(h) = r(\alpha)$ .

Observe that in particular  $\varphi(r(\alpha), \alpha) \in \mathcal{G}^{(0)}$  for every  $\alpha \in \Lambda$ .

Now, we state the properties that a cocycle will enjoy (in a similar list as that of [15, Section 7]). But instead of impose them, we will try to deduce from the definition, as in [9, Section 3].

First step is to fix the requirement to guarantee that the action of  $\mathcal{G}$  is compatible with the composition in  $\Lambda$ . We will introduce minimal requirements to guarantee this fact when constructing our "self-similar" actions, and also that we can associate a suitable small category to the action and the cocycle.

**Definition 3.3.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , and let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ . A (partial) cocycle  $\varphi$  for the action of  $\mathcal{G}$  on  $\Lambda$  is said to be a *category cocycle* if for every  $g \in \mathcal{G}$ ,  $\alpha \in \Lambda$  with  $s(g) = r(\alpha)$  and every  $\beta \in s(\alpha)\Lambda$  we have that:

 $(CC1) \ \varphi(g, d(\phi(g))) = g, \\ (CC2) \ \varphi(g, \alpha\beta) = \varphi(\varphi(g, \alpha), \beta),$ 

(CC3)  $g \cdot (\alpha \beta) = (g \cdot \alpha)(\varphi(g, \alpha) \cdot \beta).$ 

If we have an action of  $\mathcal{G}$  on  $\Lambda$ , and  $\varphi$  is a category cocycle for this action, we will say that  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is a *category system*.

**Remark 3.4.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. Then, by condition (5) in Definition 3.3, the action of  $\mathcal{G}$  on  $\Lambda$  is self-similar. Moreover, given  $g \in \mathcal{G}$  and  $\alpha \in s(g)\Lambda$ , we have that  $\phi(\varphi(g, \alpha)) = \phi(g)|_{\alpha}$ . Indeed, if  $\beta \in s(\alpha)\Lambda$  then  $\phi(g)(\alpha\beta) = \phi(g)(\alpha)\phi(g)|_{\alpha}(\beta)$ . On the other hand  $\phi(g)(\alpha\beta) = g \cdot (\alpha\beta) = (g \cdot \alpha)(\varphi(g, \alpha) \cdot \beta) = \phi(g)(\alpha)(\phi(\varphi(g, \alpha))(\beta))$ . By left cancellation of  $\Lambda$  it follows that  $\phi|_{\alpha}(\beta) = \phi(\varphi(g, \alpha))(\beta)$ , and hence

$$\phi(g)_{|\alpha} = \phi(\varphi(g,\alpha)).$$

**Lemma 3.5.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , and let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ . Let  $\varphi$  be a category cocycle for the action of  $\mathcal{G}$  on  $\Lambda$ . Then for every  $g \in \mathcal{G}$ ,  $\alpha \in \Lambda$  with  $s(g) = r(\alpha)$  we have that:

 $\begin{array}{l} (\mathrm{CC4}) \ s(g \cdot \alpha) = \varphi(g, \alpha) \cdot s(\alpha) = r(\varphi(g, \alpha)), \\ (\mathrm{CC5}) \ s(\alpha) = \varphi(r(\alpha), \alpha). \end{array}$ 

*Proof.* For (CC4), using Remark 3.4,

$$\begin{aligned}
\varphi(g,\alpha) \cdot s(\alpha) &= \phi(g)_{|\alpha}(s(\alpha)), \text{ by } (CC3) \\
&= c(\phi(g)_{|\alpha}), \text{ by Lemma } 2.4(2) \\
&= s(\phi(g)(\alpha)), \text{ by Lemma } 2.4(2) \\
&= s(g \cdot \alpha),
\end{aligned}$$

this gives the first half of (CC4). For the second half,

$$c(\phi(g)_{|\alpha}) = c(\phi(\varphi(g,\alpha))), \text{ by } (CC3)$$
$$= r(\varphi(g,\alpha)).$$
  
C5),  $\alpha = r(\alpha) \cdot \alpha$ , so  $s(\alpha) = s(r(\alpha) \cdot \alpha) = \varphi(r(\alpha), \alpha) \cdot s(\alpha)$  by (CC3). The

For (CC5),  $\alpha = r(\alpha) \cdot \alpha$ , so  $s(\alpha) = s(r(\alpha) \cdot \alpha) = \varphi(r(\alpha), \alpha) \cdot s(\alpha)$  by (CC3). Therefore,  $\varphi(r(\alpha), \alpha) = s(\alpha)$ .

**Remark 3.6.** Similarly, (CC1) and (CC2) will follow from (CC3), modulo the action homomorphism  $\phi$ . In particular, when the action homomorphism is injective, (CC1) and (CC2) are direct consequences of (CC3).

**Example 3.7.** If  $\Lambda$  is a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , then  $\varphi : \operatorname{PIso}(\Lambda, \mathbf{d})_d \times_r \Lambda \to \operatorname{PIso}(\Lambda, \mathbf{d})$  defined by  $\varphi(f, \alpha) = f_{|\alpha|}$  is a category cocyle (Lemmas 2.3 & 2.4), so  $(\Lambda, \mathbf{d}, \operatorname{PIso}(\Lambda, \mathbf{d}), \varphi)$  is a category system.

The property of being a category cocycle is the correct version of [8, (2.3)], as we will see. Let us determine which are the basic properties satisfied by a category cocycle. These properties, joint with Definition 3.3, are analog to those proved in [9, Lemma 3.4 & Proposition 3.6].

**Proposition 3.8.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  a category system. Then, for every  $g \in \mathcal{G}$ , every  $\alpha, \beta \in \Lambda$  with  $s(g) = r(\alpha), s(\alpha) = r(\beta)$ , we have that:

(1)  $r(g \cdot \alpha) = g \cdot r(\alpha).$ (2)  $s(\varphi(g, \alpha)) = s(\alpha).$ (3)  $\varphi(g, \alpha)^{-1} = \varphi(g^{-1}, g \cdot \alpha).$ 

*Proof.* Let  $g \in \mathcal{G}$ , let  $\alpha, \beta \in \Lambda$  with  $s(g) = r(\alpha), s(\alpha) = r(\beta)$ .

- (1) Since  $r(\alpha) = s(g)$  and  $g \cdot s(g) = r(g)$ , we have that  $r(g \cdot \alpha) = r(g) = g \cdot s(g) = g \cdot r(\alpha)$ .
- (2) By (CC4),  $\varphi(g, \alpha) \cdot s(\alpha) = r(\varphi(g, \alpha))$ . Thus,  $s(\varphi(g, \alpha)) = s(\alpha)$ .
- (3) By the cocycle condition and (CC5)

$$s(\alpha) = \varphi(g^{-1}g, \alpha) = \varphi(g^{-1}, g \cdot \alpha)\varphi(g, \alpha),$$

whence  $\varphi(g, \alpha)^{-1} = \varphi(g^{-1}, g \cdot \alpha)$ .

Now, we will fix a definition of Zappa-Szép product for a category system  $(\Lambda, \mathcal{G}, \varphi)$ , similar to that in [2, Section 4], using the strategy introduced in [4].

**Definition 3.9.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. We denote by  $\Lambda \Join^{\varphi} \mathcal{G}$  the set

$$\Lambda \bowtie^{\varphi} \mathcal{G} := \Lambda_s \times_r \mathcal{G} = \{(\alpha, g) \in \Lambda \times \mathcal{G} : s(\alpha) = r(g)\},\$$

with distinguished elements

$$(\Lambda \Join^{\varphi} \mathcal{G})^{(0)} := \Lambda^0 \Join^{\varphi} \mathcal{G}^{(0)}$$

We equip this pair of sets with range and source maps  $r, s : \Lambda \Join^{\varphi} G \to (\Lambda \Join^{\varphi} G)^{(0)}$ defined by

$$r(\alpha, g) := (r(\alpha), r(\alpha))$$
 and  $s(\alpha, g) := (s(g), s(g)) = (g^{-1} \cdot s(\alpha), s(g))$ ,

for every  $(\alpha, g) \in \Lambda \Join^{\varphi} \mathcal{G}$ . Observe that the later equality holds because  $g \cdot s(g) = r(g) = s(\alpha)$ , whence  $g^{-1} \cdot s(\alpha) = g^{-1} \cdot r(g) = s(g)$ .

Moreover, given  $(\alpha, g), (\beta, h) \in \Lambda \Join^{\varphi} \mathcal{G}$  with  $s(\alpha, g) = r(\beta, h)$ , we define the composition of two elements as follows:

$$(\alpha, g)(\beta, h) := (\alpha(g \cdot \beta), \varphi(g, \beta)h).$$

We now adapt the arguments of [2, Proposition 4.6] and [2, Proposition 4.13] to prove the next results.

**Proposition 3.10.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. If given  $(\alpha, g), (\beta, h) \in \Lambda \Join^{\varphi} \mathcal{G}$  with  $s(\alpha, g) = r(\beta, h)$ , we define the composition of these two elements by

$$\alpha, g)(\beta, h) := (\alpha(g \cdot \beta), \varphi(g, \beta)h),$$

then  $\Lambda \Join^{\varphi} \mathcal{G}$  is a small category.

*Proof.* First observe that, given  $(\alpha, g), (\beta, h) \in \Lambda \Join^{\varphi} \mathcal{G}$  with  $s(\alpha, g) = r(\beta, h),$ 

$$r(\beta) = g^{-1} \cdot s(\alpha)$$
 and  $r(\beta) = s(g)$ .

Whence  $g \cdot \beta$  is well-defined, and since  $r(\beta) = g^{-1} \cdot s(\alpha)$  so does  $\alpha(g \cdot \beta)$ .

On the other hand we have that

$$s(\alpha(g \cdot \beta)) = s(g \cdot \beta) = r(\varphi(g, \beta)) = r(\varphi(g, \beta)h)$$

and

$$s(\varphi(g,\beta)) = s(\beta) = r(h)$$

Then, the product

$$(\alpha, g)(\beta, h) := (\alpha(g \cdot \beta), \varphi(g, \beta)h)$$
 .

is well-defined.

Now, observe that

$$r((\alpha, g)(\beta, h)) = r((\alpha(g \cdot \beta), \varphi(g, \beta)h)) = (r(\alpha(g \cdot \beta)), r(\alpha(g \cdot \beta)))$$
$$= (r(\alpha), r(\alpha)) = r(\alpha, g),$$

and

$$s((\alpha, g)(\beta, h)) = s((\alpha(g \cdot \beta), \varphi(g, \beta)h)) = (s(\varphi(g, \beta)h), s(\varphi(g, \beta)h))$$
$$= (s(h), s(h)) = s(\beta, h).$$

Also, given  $(\gamma, f) \in \Lambda \Join^{\varphi} \mathcal{G}$ , we have that

$$\begin{aligned} ((\alpha,g)(\beta,h))(\gamma,f) &= (\alpha(g \cdot \beta), \varphi(g,\beta)h)(\gamma,f) \\ &= (\alpha(g \cdot \beta)(\varphi(g,\beta)h \cdot \gamma), \varphi(\varphi(g,\beta)h,\gamma)f) \\ &= (\alpha(g \cdot (\beta(h \cdot \gamma)), \varphi(\varphi(g,\beta)h,\gamma)f) \\ &= (\alpha(g \cdot (\beta(h \cdot \gamma)), \varphi(\varphi(g,\beta),h \cdot \gamma)\varphi(h,\gamma)f) \\ &= (\alpha(g \cdot (\beta(h \cdot \gamma)), \varphi(g,\beta(h \cdot \gamma))\varphi(h,\gamma)f) \\ &= (\alpha,g)(\beta(h \cdot \gamma), \varphi(h,\gamma)f) \\ &= (\alpha,g)((\beta,h)(\gamma,f)) \,. \end{aligned}$$

Now, let  $(u, u) \in \Lambda^0 \Join^{\varphi} \mathcal{G}^{(0)}$ , so  $u \in \Lambda^0 = \mathcal{G}^{(0)}$ . Then,

$$r(u, u) = (u, u)$$
 and  $s(u, u) = (u, u)$ .

Finally,

$$r(\alpha, g)(\alpha, g) = (r(\alpha), r(\alpha))(\alpha, g) = (r(\alpha)(r(\alpha) \cdot \alpha), \varphi(r(\alpha), \alpha)g) = (\alpha, g),$$

and

$$\begin{aligned} (\alpha, g)s(\alpha, g) = & (\alpha, g)(s(g), s(g)) = (\alpha(g \cdot s(g)), \varphi(g, s(g))s(g)) \\ = & (\alpha r(g), gs(g)) = (\alpha, g) \,, \end{aligned}$$

So we are done

**Lemma 3.11.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. Then,  $(\Lambda \Join^{\varphi} \mathcal{G})^{-1} = \Lambda^{-1}{}_s \times_r \mathcal{G}$ .

*Proof.* If  $(\alpha, g) \in (\Lambda \Join^{\varphi} \mathcal{G})^{-1}$ , then there exists  $(\beta, h) \in \Lambda \Join^{\varphi} \mathcal{G}$  such that

$$(\alpha, g)(\beta, h) = (\alpha(g \cdot \beta), \varphi(g, \beta)h) = r(\alpha, g) = (r(\alpha), r(\alpha))$$

Therefore,  $\alpha(g \cdot \beta) = r(\alpha)$ , and so  $\alpha \in \Lambda^{-1}$ . Hence,  $(\alpha, g) \in \Lambda^{-1}{}_s \times_r \mathcal{G}$ . If  $(\alpha, g) \in \Lambda^{-1}{}_s \times_r \mathcal{G}$ , then

$$(\alpha, g)(g^{-1} \cdot \alpha^{-1}, \varphi(g, g^{-1} \cdot \alpha^{-1})^{-1}) = (r(\alpha), r(\alpha)),$$

and so  $(\alpha, g) \in (\Lambda \Join^{\varphi} \mathcal{G})^{-1}$ .

**Proposition 3.12.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. Then:

- (1)  $\Lambda \Join^{\varphi} \mathcal{G}$  is left cancellative.
- (2) If  $\Lambda$  is finitely (singly) aligned, then:
  - (a)  $(\alpha, g)(\Lambda \Join^{\varphi} \mathcal{G}) \cap (\beta, h)(\Lambda \Join^{\varphi} \mathcal{G}) = (\alpha \Lambda \cap \beta \Lambda)_s \times_r \mathcal{G}.$
  - (b)  $\Lambda \bowtie^{\varphi} \mathcal{G}$  is finitely (singly) aligned.

## Proof.

(1) By hypothesis,  $\Lambda$  is left cancellative. Let  $(\alpha, g), (\beta, h), (\gamma, k) \in \Lambda \Join^{\varphi} \mathcal{G}$  such that  $(\alpha, g)(\beta, h) = (\alpha, g)(\gamma, k)$ . Then,  $(\alpha(g \cdot \beta), \varphi(g, \beta)h) = (\alpha(g \cdot \gamma), \varphi(g, \gamma)k)$ . Thus, we have that  $\alpha(g \cdot \beta) = \alpha(g \cdot \gamma)$ , and by left cancellation we get  $g \cdot \beta = g \cdot \gamma$ , whence  $\beta = \gamma$ . Moreover,  $\varphi(g, \beta)h = \varphi(g, \gamma)k = \varphi(g, \beta)k$ , and so h = k. Thus,  $(\beta, h) = (\gamma, k)$ , as desired.

- (2) Let us prove both asserts:
  - (a) First, let  $(\alpha, g), (\beta, h) \in \Lambda \Join^{\varphi} \mathcal{G}$  such that  $(\alpha, g) \cap (\beta, h)$ . This means that there exist  $(\gamma, k), (\delta, l) \in \Lambda \Join^{\varphi} \mathcal{G}$  such that  $z := (\alpha, g)(\gamma, k) = (\beta, h)(\delta, l)$ , whence

$$z = (\alpha(g \cdot \gamma), \varphi(g, \gamma)k) = (\beta(h \cdot \delta), \varphi(h, \delta)l).$$

In particular,  $\alpha(g \cdot \gamma) = \beta(h \cdot \delta) \in \alpha \Lambda \cap \beta \Lambda$ . Moreover, since  $z \in \Lambda \Join^{\varphi} \mathcal{G}$ , we conclude that  $z \in (\alpha \Lambda \cap \beta \Lambda)_s \times_r \mathcal{G}$ .

Conversely, suppose that  $z \in (\alpha \Lambda \cap \beta \Lambda)_s \times_r \mathcal{G}$ . Then,  $z = (\varepsilon, m)$  with  $\varepsilon \in \alpha \Lambda \cap \beta \Lambda$ ,  $m \in \mathcal{G}$  and  $s(\varepsilon) = c(\phi(m))$ . Set  $\varepsilon = \alpha \lambda$ , and notice that, for any  $(\alpha, g) \in \Lambda \bowtie^{\varphi} \mathcal{G}$ ,  $(\alpha, g) = (\alpha, s(\alpha))(s(\alpha), g) \in \Lambda \bowtie^{\varphi} \mathcal{G}$ , with  $(s(\alpha), g) \in (\Lambda \bowtie^{\varphi} \mathcal{G})^{-1}$  with inverse  $(g^{-1} \cdot s(\alpha), g^{-1})$ . Thus,  $(\alpha, \operatorname{id}_{s(\alpha)}) \approx (\alpha, g)$  in  $\Lambda$ . Hence,  $z = (\alpha \lambda, m) = (\alpha, s(\alpha))(\lambda, m) \in (\alpha, s(\alpha))(\Lambda \bowtie^{\varphi} \mathcal{G}) = (\alpha, g)(\Lambda \bowtie^{\varphi} \mathcal{G})$ . Similarly, we prove that  $z \in (\beta, h)(\Lambda \bowtie^{\varphi} \mathcal{G})$ . Thus,  $z \in (\alpha, g)(\Lambda \bowtie^{\varphi} \mathcal{G}) \cap (\beta, h)(\Lambda \bowtie^{\varphi} \mathcal{G})$ , so we are done.

(b) By part (a), for any  $\gamma \in \Lambda$  we have  $\gamma \Lambda_s \times_r \mathcal{G} = (\gamma, s(\gamma))(\Lambda \Join^{\varphi} \mathcal{G})$ .

Suppose that  $\Lambda$  is finitely (singly) aligned. Then, using part (a), we have that

1

$$\begin{aligned} (\alpha,g)(\Lambda\bowtie^{\varphi}\mathcal{G})\cap(\beta,h)(\Lambda\bowtie^{\varphi}\mathcal{G}) &= (\alpha\Lambda\cap\beta\Lambda)_{s}\times_{r}\mathcal{G} = \left(\bigcup_{\gamma\in\alpha\vee\beta}\gamma\Lambda\right)_{s}\times_{c}\mathcal{G} \\ &= \bigcup_{\gamma\in\alpha\vee\beta}(\gamma\Lambda_{s}\times_{r}G) = \bigcup_{\gamma\in\alpha\vee\beta}(\gamma,s(\gamma))(\Lambda\bowtie^{\varphi}\mathcal{G}) \\ &= \bigcup_{\eta\in(\alpha\vee\beta)_{s}\times_{r}\Lambda^{0}}\eta(\Lambda\bowtie^{\varphi}\mathcal{G}) \,. \end{aligned}$$

Thus,  $\Lambda \Join^{\varphi} \mathcal{G}$  is finitely (singly) aligned, as desired.

Also, we can prove an analog of [2, Lemma 4.15]

**Lemma 3.13.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. Take any  $(v, v) \in (\Lambda \Join^{\varphi} \mathcal{G})^{0}$ , and let  $F \subseteq (v, v)(\Lambda \bowtie^{\varphi} \mathcal{G})$ . Set

$$H := \{ \alpha \in v\Lambda : \text{ there is } g \in \mathcal{G} \text{ such that } (\alpha, g) \in F \}.$$

Then, F is exhaustive at (v, v) if and only if H is exhaustive at v.

*Proof.* Since  $(\alpha, s(\alpha)) \approx (\alpha, g)$  for all  $(\alpha, g) \in \Lambda \Join^{\varphi} \mathcal{G}$ , by [2, Lemma 2.3] we can assume without loss of generality that  $F = H_s \times_r \Lambda^0$ .

First, suppose that F is exhaustive at (v, v). If  $\beta \in v\Lambda$ , then  $(\beta, s(\beta)) \in (v, v)(\Lambda \Join^{\varphi} \mathcal{G})$ . Then, there exists  $(\alpha, s(\alpha)) \in F$  such that

$$\emptyset \neq (\alpha, s(\alpha))(\Lambda \bowtie^{\varphi} \mathcal{G}) \cap (\beta, s(\beta))(\Lambda \bowtie^{\varphi} \mathcal{G}) = (\alpha \Lambda \cap \beta \Lambda)_s \times_r \mathcal{G}.$$

Hence,  $\alpha \Lambda \cap \beta \Lambda \neq \emptyset$ , and since  $\alpha \in H$ , we conclude that H is exhaustive at v.

Conversely, suppose that H is exhaustive at v. Set  $(\beta, g) \in (v, v)(\Lambda \Join^{\varphi} \mathcal{G})$ . Then,  $\beta \in v\Lambda$ , so that there exists  $\alpha \in H$  such that  $\alpha\Lambda \cap \beta\Lambda \neq \emptyset$ . Since  $(\beta, g) \approx (\beta, s(\beta))$  in  $\Lambda \bowtie^{\varphi} \mathcal{G}$ , we have that

$$\begin{aligned} &(\alpha, s(\alpha))(\Lambda \Join^{\varphi} \mathcal{G}) \cap (\beta, g)(\Lambda \Join^{\varphi} \mathcal{G}) \\ &= (\alpha, s(\alpha))(\Lambda \Join^{\varphi} \mathcal{G}) \cap (\beta, s(\beta))(\Lambda \Join^{\varphi} \mathcal{G}) \\ &= (\alpha\Lambda \cap \beta\Lambda)_s \times_r \mathcal{G} \neq \emptyset \,. \end{aligned}$$

Since  $(\alpha, s(\alpha)) \in F$ , we conclude that F is exhaustive at (v, v), as desired.

**Proposition 3.14.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP, let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. Then the map  $\mathbf{d} : \Lambda \Join^{\varphi} \mathcal{G} \to \Gamma$  defined by  $\mathbf{d}(\alpha, g) = \mathbf{d}(\alpha)$  for every  $(\alpha, g) \in \Lambda \Join^{\varphi} \mathcal{G}$  is a length function satisfying the WFP.

*Proof.* The map  $\mathbf{d} : \Lambda \Join^{\varphi} \mathcal{G} \to \Gamma$  given by  $\mathbf{d}(\alpha, g) = \mathbf{d}(\alpha)$  for every  $(\alpha, g) \in \Lambda \Join^{\varphi} \mathcal{G}$  is clearly well-defined. Now let  $(\alpha, g), (\beta, h) \in \Lambda \Join^{\varphi} \mathcal{G}$  with  $s(\alpha, g) = r(\beta, h)$ . Then,

$$\begin{aligned} \mathbf{d}((\alpha, g)(\beta, h)) &= \mathbf{d}(\alpha(g \cdot \beta), \varphi(g, \beta)h) = \mathbf{d}(\alpha(g \cdot \beta)) \\ &= \mathbf{d}(\alpha)\mathbf{d}(g \cdot \beta) = \mathbf{d}(\alpha)\mathbf{d}(\phi(g)(\beta)) \\ &= \mathbf{d}(\alpha)\mathbf{d}(\beta) = \mathbf{d}(\alpha, g)\mathbf{d}(\beta, h) \,, \end{aligned}$$

since  $\phi(g) \in \operatorname{PIso}(\Lambda, \mathbf{d})$ . So, **d** is a length function of  $\Lambda \Join^{\varphi} \mathcal{G}$ .

Now, let  $(\alpha, g) \in \Lambda \Join^{\varphi} \mathcal{G}$ , with  $\mathbf{d}(\alpha, g) = \mathbf{d}(\alpha) := \gamma$ . Then, by the WFP, given  $\gamma_1, \gamma_2 \in \Gamma$  such that  $\gamma = \gamma_1 \gamma_2$ , there exist  $\alpha_1, \alpha_2 \in \Lambda$  with  $\alpha = \alpha_1 \alpha_2$  and  $\mathbf{d}(\alpha_1) = \gamma_1$  and  $\mathbf{d}(\alpha_2) = \gamma_2$ . Thus, we have that

$$(\alpha, g) = (\alpha_1, s(\alpha_1))(\alpha_2, g),$$

and

$$\gamma = \mathbf{d}(\alpha) = \mathbf{d}(\alpha, g) = \mathbf{d}(\alpha_1, s(\alpha_1))\mathbf{d}(\alpha_2, g) = \mathbf{d}(\alpha_1)\mathbf{d}(\alpha_2) = \gamma_1\gamma_2.$$

Let us suppose there exist  $(\beta_1, h_1), (\beta_2, h_2) \in \Lambda \Join^{\varphi} \mathcal{G}$  with

$$(\beta_1, h_1)(\beta_2, h_2) = (\beta_1(h_1 \cdot \beta_2), \varphi(h_1, \beta_2)h_2) = (\alpha, g)$$

such that  $\mathbf{d}(\beta_1, h_1) = \mathbf{d}(\beta_1) = \gamma_1$  and  $\mathbf{d}(\beta_2, h_2) = \mathbf{d}(\beta_2) = \gamma_2$ . By the WFP there exists  $f_1, f_2 \in \Lambda^{-1}$  such that  $\beta_1 = \alpha_1 f_1$  and  $h_1 \cdot \beta_2 = f_2 \alpha_2$ , whence

$$(\beta_1, h_1) = (\alpha_1 f_1, h_1) = (\alpha_1, s(\alpha_1))(f_1, h_1)$$

and

$$\begin{aligned} (\beta_2, h_2) &= (h_1^{-1} \cdot (h_1 \cdot \beta_2), \varphi(h_1, \beta_2)^{-1}g) \\ &= (h_1^{-1} \cdot (h_1 \cdot \beta_2), \varphi(h_1, h_1^{-1} \cdot f_2 \alpha_2)^{-1}g) \\ &= ((h_1^{-1} \cdot (f_2 \alpha_2), \varphi(h_1^{-1}, f_2 \alpha_2)g) \\ &= ((h_1^{-1} \cdot f_2)(\varphi(h_1^{-1}, f_2) \cdot \alpha_2), \varphi(\varphi(h_1^{-1}, f_2), \alpha_2)g) \\ &= (h_1^{-1} \cdot f_2, \varphi(h_1^{-1}, f_2))(\alpha_2, g) \\ &= (h_1^{-1} \cdot f_2, \varphi(h_1, h_1^{-1} \cdot f_2)^{-1})(\alpha_2, g) \\ &= (f_2^{-1}, h_1)^{-1}(\alpha_2, g) , \end{aligned}$$

as desired.

**Remark 3.15.** Observe that in the proof of the above Proposition that if  $\Lambda$  satisfies the WFP as it is defined in [12] then so does the Zappa-Szép product.

**Definition 3.16.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , and let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ . We say that a category system  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is *pseudo-free* if  $\Lambda$  is an action-free category, and whenever  $g \cdot \alpha = f\alpha$  and  $\varphi(g, \alpha) = s(\alpha)$  for some  $\alpha \in \Lambda, g \in \mathcal{G}$  and  $f \in \Lambda^{-1}$ , then  $g \in \mathcal{G}^{(0)}$ .

**Proposition 3.17.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP, let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. Then,  $\Lambda \bowtie^{\varphi} \mathcal{G}$  is right cancellative if and only if  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is pseudo-free.

*Proof.* First suppose that  $\Lambda \Join^{\varphi} \mathcal{G}$  is right cancellative. Then  $\Lambda$  is right cancellative too, and hence action-free. Now, let us suppose there exist  $\alpha \in \Lambda$ ,  $g \in \mathcal{G}$  and  $f \in \Lambda^{-1}$  such that  $g \cdot \alpha = f \alpha$  and  $\varphi(g, \alpha) \in \mathcal{G}^{(0)}$ . Thus,

$$(r(g),g)(\alpha,s(\alpha)) = (f\alpha,s(\alpha)) = (f,s(f))(\alpha,s(\alpha))$$

but by right cancellation  $g = s(f) \in \mathcal{G}^{(0)}$ . Hence,  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is pseudo-free.

On the other hand, suppose that  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is pseudo-free, and let  $(\alpha, g) \in \Lambda \Join^{\varphi} \mathcal{G}$ and  $(f, h) \in (\Lambda \Join^{\varphi} \mathcal{G})^{-1}$  such that

$$(f,h)(\alpha,g) = (f(h \cdot \alpha), \varphi(h,\alpha)g) = (\alpha,g),$$

so  $\alpha = f(h \cdot \alpha)$  and  $\varphi(h, \alpha) = r(g)$ , and hence  $f^{-1}\alpha = h \cdot \alpha$ . But then, by pseudo-freeness, we have that  $h = r(\alpha)$ . Hence,  $f^{-1}\alpha = \alpha$ , but since  $\Lambda$  is action-free we have  $f = r(\alpha)$ . Therefore,  $(f, h) = (r(\alpha), r(\alpha)) \in (\Lambda \Join^{\varphi} \mathcal{G})^0$ , so  $\Lambda \Join^{\varphi} \mathcal{G}$  is action-free, and hence right cancellative.

# 4. Length functions in LCSC

Now we will see that Zappa-Szép products of LCSC arises naturally among LCSC. In [11] they defined the *generalized higher rank k-graphs* categories and described them as Zappa-Szép products. Here we slightly generalize their arguments to a more general class of LCSC.

Let  $\Lambda$  be a LCSC, and let M be a monoid with neutral element 1, and let  $\mathbf{d} : \Lambda \to M$  be a length function satisfying:

(LF1)  $\mathbf{d}^{-1}(1) = \Lambda^{-1}$ ,

(LF2) for every  $\alpha \in \Lambda$ , if  $\mathbf{d}(\alpha) = m_1 m_2$  for  $m_1, m_2 \in M$  then there exist  $\alpha_1, \alpha_2 \in M$ such that  $\alpha = \alpha_1 \alpha_2$  and  $\mathbf{d}(\alpha_i) = m_i$  for i = 1, 2.

Observe that if  $\mathbf{d} : \Lambda \to M$  satisfies the WFP then it satisfies conditions (LF1) and (LF2).

**Remark 4.1.** A length function  $\mathbf{d} : \Lambda \to M$  satisfying the conditions (LF1) and (LF2) forces the monoid M to be conical. Let  $m_1, m_2 \in M$  such that  $1 = m_1 m_2$ . Take any  $\alpha \in \Lambda^{-1}$ , so  $1 = \mathbf{d}(\alpha) = m_1 m_2$ , and hence by (LF2) there exist  $\alpha_1, \alpha_2$  such that  $\alpha = \alpha_1 \alpha_2$  with  $\mathbf{d}(\alpha_i) = m_i$  for i = 1, 2. Thus,  $s(\alpha) = (\alpha^{-1} \alpha_1) \alpha_2$ , so that  $\alpha_2 \in \Lambda^{-1}$ . Hence,  $\alpha_1 = \alpha \alpha_2^{-1} \in \Lambda^{-1}$ . By (LF1),  $m_i = \mathbf{d}(\alpha_i) = 0$  for i = 1, 2. Thus, M is conical.

We say that  $e \in M$  is an *atom* if  $e \notin M^{-1}$  and whenever  $e = m_1m_2$  then either  $m_1 = 1$ or  $m_2 = 1$ . We denote by  $M_a$  the set of atoms of M. We say that M is *atomic* if M is generated by its atoms. We say that  $\alpha \in \Lambda \setminus \Lambda^{-1}$  is an *atom* if whenever  $\alpha = \beta \gamma$  then either  $\beta$  or  $\gamma$  is in  $\Lambda^{-1}$ . We denote by  $\Lambda_a$  the atoms of  $\Lambda$ .

**Lemma 4.2.** Let  $\Lambda$  be a LCSC, let M be a conical monoid, and let  $\mathbf{d} : \Lambda \to M$  be a length function satisfying (LF1) and (LF2). Then,  $\alpha$  is an atom if and only if  $\mathbf{d}(\alpha)$  is an atom. In particular,  $\Lambda_a = \bigcup_{e \in M_a} \mathbf{d}^{-1}(e)$ .

*Proof.* Let  $e \in M$  be an atom, and let  $\alpha \in \Lambda$  with  $\mathbf{d}(\alpha) = e$ . If  $\alpha = \beta \gamma$ , then  $e = \mathbf{d}(\alpha) = \mathbf{d}(\beta\gamma) = \mathbf{d}(\beta)\mathbf{d}(\gamma)$ . Hence, either  $\mathbf{d}(\beta) = 1$  or  $\mathbf{d}(\gamma) = 1$ , or equivalently either  $\beta \in \Lambda^{-1}$  and  $\gamma \in \Lambda^{-1}$ . Thus,  $\alpha$  is an atom.

Now, let  $\alpha \in \Lambda$  be an atom of  $\Lambda$ . Suppose that  $\mathbf{d}(\alpha) = m$  is not an atom, so there exist  $m_1, m_2 \in M \setminus \{1\}$  such that  $m = m_1 m_2$ . By (LF2) there exist  $\alpha_1, \alpha_2$  in  $\Lambda$  such that  $\alpha = \alpha_1 \alpha_2$  and  $\mathbf{d}(\alpha_i) = m_i$  for  $i = 1, \ldots, k$ , and by (LF1)  $\alpha_1$  and  $\alpha_2$  are not invertible. This contradicts that  $\alpha$  is an atom.

The following lemma is an easy consequence of Lemma 4.2.

**Lemma 4.3.** Let  $\Lambda$  be a LCSC, let M be an atomic and conical monoid, and let  $\mathbf{d}$ :  $\Lambda \to M$  be a length function satisfying (LF1) and (LF2). Then every  $\alpha \in \Lambda \setminus \Lambda^{-1}$  can be written as a finite composition of atoms.

**Remark 4.4.** Under the hypothesis of Lemma 4.3 the decomposition need not be unique. For example, let a length function  $\mathbf{d} : \Lambda \to M$  satisfying conditions (LF1) and (LF2) where  $M = \langle 2, 5 \rangle_{\mathbb{Z}^+} \subsetneq \mathbb{Z}^+$ . Then, by Lemma 4.2, we have that  $\Lambda_a = \mathbf{d}^{-1}(2) \cup \mathbf{d}^{-1}(5)$ . Thus, for any  $\alpha \in \Lambda$  with  $\mathbf{d}(\alpha) = 10$ , there exist atomic factorizations  $\alpha = \beta_1 \cdots \beta_5 = \gamma_1 \gamma_2$  with  $\mathbf{d}(\beta_i) = 2$  for every  $i = 1, \ldots, 5$  and  $\mathbf{d}(\gamma_j) = 5$  for every j = 1, 2.

Given a LCSC  $\Lambda$  and  $\alpha \in \Lambda$  we denote by  $\alpha \Lambda = \{\alpha \gamma : r(\gamma) = s(\alpha)\}$  a principal right ideal of  $\Lambda$ . A principal ideal  $\alpha \Lambda$  is call maximal if it is a maximal principal ideal properly contained in  $r(\alpha)\Lambda$ . From the above observations we can easily adapt the following results from [12, Section 2] to our context.

**Proposition 4.5** ([12, Lemma 2.3]). Let  $\Lambda$  be a LCSC, let M be a conical atomic monoid, and let  $\mathbf{d} : \Lambda \to M$  be a length function satisfying (LF1) and (LF2). Then  $\alpha\Lambda$  is maximal if and only if  $\alpha$  is an atom.

**Proposition 4.6** ([12, Proposition 2.6]). Let  $\Lambda$  be a LCSC, let M be a conical atomic monoid, and let  $\mathbf{d} : \Lambda \to M$  be a length function satisfying (LF1) and (LF2), and

let  $B \subseteq \Lambda_a$  be a transversal of generators of maximal principal right ideals. Then,  $\Lambda = B^* \Lambda^{-1}$  where  $B^*$  is the subcategory of  $\Lambda$  generated by B.

The next step is to realize such a  $\Lambda$  as a Zappa-Szép product  $B^* \bowtie \Lambda^{-1}$ . In order to do that we need to impose an extra condition in the category  $\Lambda$ :

**Definition 4.7.** Let  $B \subseteq \Lambda_a$  be a transversal of generators of maximal principal right ideals, then we say that B satisfies the  $\mathcal{R}$ -condition if whenever  $\alpha = \beta g$  for  $\alpha, \beta \in B^*$  and  $g \in \Lambda^{-1}$  we have that  $g \in \Lambda^0$ .

**Proposition 4.8** ([12, Theorem 4.2]). Let  $\Lambda$  be a LCSC, let M be a conical atomic monoid, and let  $\mathbf{d} : \Lambda \to M$  be a length function satisfying (LF1) and (LF2), let  $B \subseteq \Lambda_a$ be a transversal of generators of maximal principal right ideals, and suppose that Bsatisfies the  $\mathcal{R}$ -condition. Then, every element of  $\Lambda$  has a unique representation as an element of  $B^*\Lambda^{-1}$ . Thus,  $\Lambda$  is the Zappa-Szép product  $B^* \bowtie \Lambda^{-1}$ . Moreover, if  $\Lambda$  satisfies the WFP, then the restriction of  $\mathbf{d}$  to  $B^*$  satisfies the UFP.

Now let  $\Lambda$  be a LCSC, let M be a conical atomic monoid, let  $\mathbf{d} : \Lambda \to M$  be a length function satisfying (LF1) and (LF2), let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , and let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system. We can naturally extend  $\mathbf{d}$  to a length function  $\mathbf{d} : \Lambda \bowtie^{\varphi} \mathcal{G} \to M$  by  $\mathbf{d}(\alpha, g) = \mathbf{d}(\alpha)$  that trivially satisfies conditions (*LF*1) and (*LF*2). Also, if  $\mathbf{d}$  satisfies the WFP on  $\Lambda$  then it also does  $\Lambda \bowtie^{\varphi} \mathcal{G}$  by Proposition 3.14. Moreover, since any transversal of generators of maximal principal right ideals of  $\Lambda$  is also a transversal of maximal principal right ideals of  $\Lambda \bowtie^{\varphi} \mathcal{G}$ , it is straightforward to check that  $\Lambda \bowtie^{\varphi} \mathcal{G}$  satisfies  $\mathcal{R}$ -condition whenever  $\Lambda$  does. Finally, observe that the action of the groupoid  $\mathcal{G}$  on  $\Lambda$  restricts to an action of  $\Lambda^{-1}$  (Remark 2.2(2)) and hence  $(\Lambda^{-1}, \mathbf{d}, \mathcal{G}, \varphi)$  is a category system too. So, we can conclude

**Corollary 4.9.** Let  $\Lambda$  be a LCSC, let M be a conical atomic monoid, let  $\mathbf{d} : \Lambda \to M$  be a length function, let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system, let  $B \subseteq \Lambda_a$  be a transversal of generators of maximal principal right ideals of  $\Lambda$ , and suppose that  $\Lambda$  satisfies the  $\mathcal{R}$ -condition. Then,  $\Lambda \Join^{\varphi} \mathcal{G}$  is the Zappa-Szép product  $B^* \bowtie (\Lambda^{-1} \bowtie^{\varphi} \mathcal{G})$ . Moreover, if  $\Lambda$  satisfies the WFP, then the restriction of  $\mathbf{d}$  to  $B^*$ satisfies the UFP.

#### 5. Properties of the tight groupoid associated to LCSC

In this section we will extend the application of the results of [15, Section 7 and 8] to category systems.

First, we will recall the essential facts needed to understand what it follows.

**Definition 5.1.** A semigroup S is an *inverse semigroup* if for every  $s \in S$  there exists a unique  $s^* \in S$  such that  $s = ss^*s$  and  $s^* = s^*ss^*$ .

Equivalently,  $\mathcal{S}$  is an inverse semigroup if and only if the subsemigroup

$$\mathcal{E}(\mathcal{S}) := \{ e \in \mathcal{S} : e^2 = e \}$$

of idempotents of  $\mathcal{S}$  is commutative.

**Definition 5.2.** Let S be an inverse semigroup, and let  $\mathcal{E}(S)$  be its subsemigroup of idempotents. Given  $e, f \in \mathcal{E}(S)$ , we say that  $e \leq f$  if and only if e = ef. We extend

this relation to a partial order as follows: given  $s, t \in S$ , we say that  $s \leq t$  if and only if  $s = ss^*t = ts^*s$ .

Given a LCSC  $\Lambda$ , we will define some inverse semigroups associated to  $\Lambda$ . First, we define the (symmetric) inverse semigroup on  $\Lambda$  as

$$\mathcal{I}(\Lambda) := \{ f : Y \to Z : Y, Z \subseteq \Lambda \text{ and } f \text{ is a bijection } \},\$$

endowed with operation

$$g \circ f : f^{-1}(\operatorname{ran}(f) \cap \operatorname{dom}(g)) \longrightarrow g(\operatorname{ran}(f) \cap \operatorname{dom}(g)),$$

and involution

$$f^* := f^{-1} : \operatorname{ran}(f) \longrightarrow \operatorname{dom}(f)$$
.

Notice that  $\mathcal{I}(\Lambda)$  has unit  $\mathrm{Id}_{\Lambda} : \Lambda \to \Lambda$  and zero being the empty map  $0 : \emptyset \to \emptyset$ .

**Definition 5.3.** Let  $\Lambda$  be a LCSC. For any  $\alpha \in \Lambda$ , we define two elements of  $\mathcal{I}(\Lambda)$ :

(1)  $\sigma^{\alpha} : \alpha \Lambda \to s(\alpha) \Lambda$  given by  $\alpha \beta \mapsto \beta$ ,

(2)  $\tau^{\alpha}: s(\alpha)\Lambda \to \alpha\Lambda$  given by  $\beta \mapsto \alpha\beta$ .

**Definition 5.4** ([15, Lemma 2.3]). Given a LCSC  $\Lambda$ , we define the inverse semigroup  $\mathcal{S}_{\Lambda} := \langle \sigma^{\alpha}, \tau^{\alpha} : \alpha \in \Lambda \rangle$ .

Given  $s \in S_{\Lambda}$  we denote by dom(s) and ran(s) the domain and the range of s respectively.

**Definition 5.5.** Let  $\Lambda$  be a finitely aligned LCSC. A nonempty subset F of  $\Lambda$  is:

- (1) Hereditary, if  $\alpha \in \Lambda$ ,  $\beta \in F$  and  $\alpha \leq \beta$  implies  $\alpha \in F$ ,
- (2) (upwards) directed,  $\alpha, \beta \in F$  implies that there exists  $\gamma \in F$  with  $\alpha, \beta \leq \gamma$ .

We denote  $\Lambda^*$  the set of nonempty, hereditary, directed subsets of  $\Lambda$ .

**Definition 5.6.** Given  $\Lambda$  a LCSC, we say that  $F \in \Lambda^*$  is maximal if whenever  $F \subset G$  with  $G \in \Lambda^*$  we have that  $G = \Lambda$ . We will denote  $\Lambda^{**} := \{F \in \Lambda^* : F \text{ is maximal}\}.$ 

**Definition 5.7.** Let  $\Lambda$  be a LCSC and  $v \in \Lambda^0$ . We say that  $F \in v\Lambda^*$  is *tight* if for every  $\alpha \in F$  and every finite set C of  $\Lambda$  with  $C \cap F = \emptyset$ , there exists  $G \in \Lambda^{**}$  with  $\alpha \in G$  and  $G \cap C = \emptyset$ . We denote by  $\Lambda_{tight}$  the set of tight hereditary directed sets.

In [15, Definition 3.21] is defined a topology on  $\Lambda_{tight}$  that makes it a locally compact, Hausdorff and totally disconnected space.

**Definition 5.8.** Let  $s = \tau^{\alpha} \sigma^{\beta} \in S_{\Lambda}$ . Then, we define

$$E_{\alpha} := \{F \in \Lambda^* : \alpha \in C\} \quad \text{and} \quad E_{\beta} := \{F \in \Lambda^* : \beta \in C\}.$$

and a map  $s: E_{\beta} \to E_{\alpha}$  given by

$$s \cdot F = \bigcup_{\beta \le \gamma, \, \gamma \in F} \left[ \alpha \sigma^{\beta}(\gamma) \right],$$

for every  $F \in \Lambda^*$ . This action restricts to a continuous action on  $\Lambda_{tight}$  [15, Corollary 4.7].

Given  $\mathcal{S}_{\Lambda} \times \Lambda_{tight} := \{(s, F) : F \cap \operatorname{dom}(s) \neq \emptyset\}$ , we define the following groupoid structure. Given  $(s, F), (t, G) \in \mathcal{S}_{\Lambda} \times \Lambda_{tight}$ :

- (1) d(s, F) = F and  $r(s, F) = s \cdot F$ ,
- (2)  $(s, F) \cdot (t, G)$  is defined if  $t \cdot G = F$ , and then  $(s, F) \cdot (t, G) = (st, G)$ ,
- (3)  $(s, F)^{-1} = (s^*, s \cdot F)$ .

We say that  $(s, F) \sim (t, G)$  if and only if F = G and there exists  $e \in \mathcal{E}(\mathcal{S}_{\Lambda})$  with  $x \in \text{dom}(e)$  and se = te. This is an equivalence relation, compatible with the groupoid structure. Thus, we define the tight groupoid of  $\Lambda$  as  $\mathcal{G}_{tight}(\Lambda) := \mathcal{S}_{\Lambda} \times \Lambda_{tight} / \sim$ , with the induced operations defined above, and the topology generated by the open sets of the form

$$\Theta(s, U) = \{ [s, F] : F \in U \cap \operatorname{dom}(s) \},\$$

for  $s \in S_{\Lambda}$  and an open set  $U \subseteq \Lambda_{tight}$ . Then  $\mathcal{G}_{tight}(\Lambda)$  is a locally compact 'etale groupoid. A nice description of  $\mathcal{G}_{tight}(S_{\Lambda})$  is given in [15, Lemma 4.8]:

$$\mathcal{G}_{tight}(\Lambda) = \{ [\tau^{\alpha} \sigma^{\beta}, F] : s(\alpha) = s(\beta), \, \beta \in F \} \,.$$

Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system, and let  $\Lambda \Join^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product. Then observe that  $\Lambda$  can be identified with the full subcategory  $\Lambda \Join^{\varphi} \mathcal{G}^{(0)}$ of  $\Lambda \Join^{\varphi} \mathcal{G}$ , and hence  $\mathcal{G}_{tight}(\Lambda)$  can be seen as an open subgroupoid of  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$ .

**Remark 5.9.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system, and let  $\Lambda \Join^{\varphi} \mathcal{G}$  be the associated Zappa- Szép product.

(1) Let  $(\alpha, g), (\beta, f) \in \Lambda \Join^{\varphi} \mathcal{G}$ , and suppose that  $(\alpha, g) \leq (\beta, f)$ . Then, there exists  $(\delta, h) \in \Lambda \Join^{\varphi} \mathcal{G}$  with  $r(\delta, h) = s(\alpha, g)$ , that is,  $r(\delta) = g^{-1} \cdot s(\alpha)$  such that

$$(\beta, f) = (\alpha, g)(\delta, h) = (\alpha(g \cdot \delta), \varphi(g, \delta)h).$$

Hence,  $\alpha(g \cdot \delta) = \beta$  and  $f = \varphi(g, \delta)h$ . Thus,  $g \cdot \delta = \sigma^{\alpha}(\beta)$  by left cancellation, and so  $\delta = g^{-1} \cdot \sigma^{\alpha}(\beta)$  and  $h = \varphi(g, g^{-1} \cdot \sigma^{\alpha}(\beta))^{-1}f = \varphi(g^{-1}, \sigma^{\alpha}(\beta))f$  because of the cocycle identity. Therefore,

$$(\alpha, g) \leq (\beta, f)$$
 if and only if  $\alpha \leq \beta$ ,

and then we have that

$$\sigma^{(\alpha,g)}(\beta,f) = (g^{-1} \cdot \sigma^{\alpha}(\beta), \varphi(g^{-1}, \sigma^{\alpha}(\beta))f) \,.$$

The above observation, together with Proposition 3.12(2)(a), shows that the map

$$F \mapsto F \Join^{\varphi} \mathcal{G} := \{(\alpha, g) \in \Lambda \Join^{\varphi} \mathcal{G} : \alpha \in F\}$$

is a bijection between  $\Lambda^*$  and  $(\Lambda \Join^{\varphi} \mathcal{G})^*$ . This bijection clearly restricts to a bijection of their tight (maximal) hereditary upper-directed subsets, so we will identify  $(\Lambda \Join^{\varphi} \mathcal{G})_{tight}$  with  $\Lambda_{tight}$ .

- (2) Let  $(\alpha, g), (\beta, f) \in \Lambda \Join^{\varphi} \mathcal{G}$  with  $s(\alpha, g) = s(\beta, f)$ , and let  $\tau^{(\alpha, g)} \sigma^{(\beta, f)} \in \mathcal{S}_{\Lambda \Join^{\varphi} \mathcal{G}}$ . Observe that, since  $(\beta, f)(\Lambda \Join^{\varphi} \mathcal{G}) = (\beta, s(f))(\Lambda \Join^{\varphi} \mathcal{G})$ , we have that  $\tau^{(\alpha, g)} \sigma^{(\beta, f)} = \tau^{(\alpha, gf^{-1})} \sigma^{(\beta, s(f))}$ .
- (3) Given  $F \in \Lambda_{tight}$  and  $(\alpha, g), (\beta, f) \in \Lambda \Join^{\varphi} \mathcal{G}$  with  $s(\alpha, g) = s(\beta, f)$ , we have that  $\tau^{(\alpha,g)}\sigma^{(\beta,f)} \cdot (F \Join^{\varphi} \mathcal{G}) = F' \Join^{\varphi} \mathcal{G}$

$$1 \quad 0 \quad (1 \ \bowtie \ g) = 1 \ \bowtie \ g$$

where  $F' := \bigcup_{\beta \leq \gamma, \gamma \in F} [\alpha((gf^{-1}) \cdot \sigma^{\beta}(\gamma))] \in \Lambda_{tight}.$ 

First we will give necessary and sufficient conditions for  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  to be a Hausdorff groupoid.

**Proposition 5.10.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system, and let  $\Lambda \Join^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product. Then,  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G})$  is a Hausdorff groupoid if and only if, given  $\alpha, \beta \in \Lambda$  and  $g \in \mathcal{G}$  with  $g^{-1} \cdot s(\alpha) = s(\beta)$ , there exists a finite subset  $H \subset s(\beta)\Lambda$  such that

- (1)  $\alpha(g \cdot \gamma) = \beta \gamma$  and  $\varphi(g, \gamma) = s(\gamma)$  for every  $\gamma \in H$ ,
- (2) for every  $\delta \in s(\beta)\Lambda$  with  $\alpha(g \cdot \delta) = \beta\delta$  and  $\varphi(g, \delta) = s(\gamma)$ , then  $\delta \cap \gamma$  for some  $\gamma \in H$ .

*Proof.* According [7, Theorem 3.16] the groupoid  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is Hausdorff if and only if for any  $s \in \mathcal{S}_{\Lambda \bowtie^{\varphi} \mathcal{G}}$  the set

$$\mathcal{I}_s := \{ e \in \mathcal{E}(\Lambda \Join^{\varphi} \mathcal{G}) : e \leq s \},\$$

admits a finite cover, that is, a finite set  $H \subseteq \mathcal{I}_s$  such that for every  $e \in \mathcal{I}_s$  there exists  $f \in H$  with  $ef \neq 0$ . Now, we will translate this equivalence to our language in terms of element of the category  $\Lambda$ . By Remark 5.9(2) we can assume without lost of generality that  $s = \tau^{(\alpha,g)}\sigma^{(\beta,s(g))}$ . Observe that, given an idempotent of the form  $e = \tau^{(\gamma,s(\gamma))}\sigma^{(\gamma,s(\gamma))}$  for some  $\gamma \in \Lambda$ , es = se = s is equivalent to say that  $\gamma = \alpha(g \cdot \sigma^{\beta}(\gamma)) = \beta\sigma^{\beta}(\gamma)$  and  $\varphi(g, \sigma^{\beta}(\gamma)) = s(\gamma)$ . Therefore, we can identify  $\mathcal{I}_s$  with the set

$$T_s := \{ \gamma \in r(\beta) \Lambda : \alpha(g \cdot \gamma) = \beta \gamma \text{ and } \varphi(g, \gamma) = s(\gamma) \}.$$

Now, given  $\gamma, \delta \in T_s$  we have that

$$(\tau^{(\beta\gamma,s(\gamma))}\sigma^{(\beta\gamma,s(\gamma))})(\tau^{(\beta\delta,s(\delta))}\sigma^{(\beta\delta,s(\delta))}) \neq 0$$

if and only  $\beta \gamma \cap \beta \delta$ , that by left cancellation is equivalent to  $\gamma \cap \delta$ . Then, having a finite cover of  $\mathcal{I}_s$  is equivalent to have a finite subset  $H \subseteq T_s$  such that for every  $\gamma \in T_s$  there exists  $\delta \in H$  with  $\gamma \cap \delta$ .

**Corollary 5.11.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP, let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system, and let  $\Lambda \bowtie^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product. If  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is pseudo-free, then  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G})$  is a Hausdorff groupoid.

*Proof.* Let  $\alpha, \beta \in \Lambda$  and  $g^{-1} \cdot s(\alpha) = s(\beta)$ , and suppose there exists  $\gamma \in s(\beta)\Lambda$  with  $\alpha(g \cdot \gamma) = \beta\gamma$  and  $\varphi(g, \gamma) = s(\gamma)$ . Then, we have that

$$\mathbf{d}(\alpha)\mathbf{d}(\gamma) = \mathbf{d}(\alpha)\mathbf{d}(g \cdot \gamma) = \mathbf{d}(\alpha(g \cdot \gamma)) = \mathbf{d}(\beta)\mathbf{d}(\gamma) = \mathbf{d}(\beta)\mathbf{d}(\gamma),$$

whence  $\mathbf{d}(\alpha) = \mathbf{d}(\beta)$ , and by the WFP there exists  $f \in \Lambda^{-1}$  such that  $g \cdot \gamma = f\gamma$ . Since  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is pseudo-free,  $g = s(\alpha)$ , so  $\alpha\gamma = \alpha(g \cdot \gamma) = \beta\gamma$ . But by Lemma 1.10  $\Lambda$  is right cancellative, and so  $\alpha = \beta$ . Hence, taking  $H = \{\alpha\}$  we can apply Proposition 5.10.

Now, we are ready to characterize minimality and effectiveness for the corresponding tight groupoid. The following results are straightforward translations of the results in [15, Section 6 & 7].

**Proposition 5.12.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system, and let  $\Lambda \Join^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product. If  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G})$  is Hausdorff or  $\Lambda_{tight} = \Lambda^{**}$ , then the following are equivalent:

- (1)  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is topologically free,
- (2) Given  $(\alpha, a), (\beta, b) \in \Lambda \Join^{\varphi} \mathcal{G}$  with  $r(\alpha, a) = r(\beta, b)$  and  $s(\alpha, a) = s(\beta, b)$ , if  $(\alpha, a)(\delta, d) \bigoplus (\beta, b)(\delta, d)$  for every  $(\delta, d) \in s(\alpha, a)(\Lambda \bowtie^{\varphi} \mathcal{G})$  then there exists  $C \in \mathsf{FE}(s(\alpha, a))$  such that  $(\alpha, a)(\gamma, d) = (\beta, b)(\gamma, d)$  for every  $(\gamma, d) \in C$ .
- (3) Given  $\alpha, \beta \in \Lambda$ ,  $a, b \in \mathcal{G}$  with  $r(a) = s(\alpha)$ ,  $r(b) = s(\beta)$ ,  $r(\alpha) = r(\beta)$  and  $a^{-1} \cdot s(\alpha) = b^{-1} \cdot s(\beta)$ , if  $\alpha(a \cdot \delta) \cap \beta(b \cdot \delta)$  for every  $\delta \in (a^{-1} \cdot s(\alpha))\Lambda$  then there exists  $C \in \mathsf{FE}(a^{-1} \cdot s(\alpha))$  such that  $\alpha(a \cdot \gamma) = \beta(b \cdot \gamma)$  and  $\varphi(a, \gamma) = \varphi(b, \gamma)$  for every  $\gamma \in F$ .

**Proposition 5.13.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system, and let  $\Lambda \Join^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product. If  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G})$  is Hausdorff or  $\Lambda_{tight} = \Lambda^{**}$ , then the following are equivalent:

- (1)  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is minimal.
- (2) For every  $(\alpha, a), (\beta, b) \in \Lambda \Join^{\varphi} \mathcal{G}$  there exists  $C \in \mathsf{FE}(\alpha, a)$  such that for each  $(\gamma, g) \in C, \ s(\beta, b)(\Lambda \Join^{\varphi} G)s(\gamma, g) \neq \emptyset.$
- (3) For every  $\alpha, \beta \in \Lambda$  there exists  $C \in \mathsf{FE}(\alpha)$  such that for each  $\gamma \in C$ , there exists  $g \in \mathcal{G}$  with  $s(\beta)\Lambda(g \cdot s(\gamma)) \neq \emptyset$ .

Given an étale groupoid  $\mathcal{G}$  with totally disconnected unit space and a field K, one can construct the so-called *Steinberg algebra*  $K(\mathcal{G})$  [20], and in [21, Theorem 3.5] there are given conditions for the simplicity of  $K(\mathcal{G})$ . Thus, we conclude with the following result.

**Theorem 5.14.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ , let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ . Let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system and  $\Lambda \Join^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product. If  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is Hausdorff or  $\Lambda_{tight} = \Lambda^{**}$ , then the following are equivalent:

- (1)  $C_r^*(\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G}))$  (the reduced groupoid  $C^*$ -algebra) is simple.
- (2) For any field K,  $K(\Lambda \bowtie^{\varphi} G)$  (the Steinberg algebra) is simple.
- (3) The following properties hold:
  - (a) Given  $\alpha, \beta \in \Lambda$ ,  $a, b \in \mathcal{G}$  with  $r(\alpha) = r(\beta)$  and  $a^{-1} \cdot s(\alpha) = b^{-1} \cdot s(\beta)$ , if  $\alpha(a \cdot \delta) \cap \beta(b \cdot \delta)$  for every  $\delta \in (a^{-1} \cdot s(\alpha))\Lambda$  then there exists  $C \in \mathsf{FE}(a^{-1} \cdot s(\alpha))$  such that  $\alpha(a \cdot \gamma) = \beta(b \cdot \gamma)$  and  $\varphi(a, \gamma) = \varphi(b, \gamma)$  for every  $\gamma \in C$ .
  - (b) For every  $\alpha, \beta \in \Lambda$  there exists  $C \in \mathsf{FE}(\alpha)$  such that for each  $\gamma \in C$ , there exists  $g \in \mathcal{G}$  with  $s(\beta)\Lambda(g \cdot s(\gamma)) \neq \emptyset$ .

### 6. Amenable groupoids

Now, we will discuss the amenability of  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$ , following the same strategy used in [15, Section 8].

Recall that  $\Gamma$  is a submonoid of a group Q with unit element  $\mathbf{1}_Q$ , and such that  $\Gamma \cap \Gamma^{-1} = \{\mathbf{1}_Q\}$ . Then, given two elements  $\gamma_1, \gamma_2 \in \Gamma$ ,

$$\gamma_1 \leq \gamma_2$$
 if and only if  $\gamma_1^{-1} \gamma_2 \in \Gamma$ .

**Lemma 6.1** (c.f.[15, Lemma 8.2]). Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ satisfying the WFP. Let  $\alpha, \beta \in \Lambda$  with  $\alpha \cap \beta$ . Then  $\alpha \leq \beta$  if and only if  $\mathbf{d}(\alpha) \leq \mathbf{d}(\beta)$ . In particular  $\alpha \approx \beta$  whenever  $\mathbf{d}(\alpha) = \mathbf{d}(\beta)$ .

**Lemma 6.2** (c.f.[15, Lemma 8.5]). Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$ satisfying the WFP, let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a category system, and let  $\Lambda \bowtie^{\varphi} \mathcal{G}$  be the associated Zappa- Szép product. Then, the map

 $\overline{\mathbf{d}}: \mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G}) \to Q, \qquad [\tau^{(\alpha,a)} \sigma^{(\beta,b)}, F \Join^{\varphi} \mathcal{G}] \mapsto \mathbf{d}(\alpha) \mathbf{d}(\beta)^{-1},$ 

is a well defined continuous groupoid homomorphism. In particular,  $\overline{\mathbf{d}}$  restricts to  $\mathcal{G}_{tight}(\Lambda)$ .

*Proof.* The proof is verbatim that of [15, Lemma 8.5], replacing [15, Remark 8.4] by Remark 5.9(1) and [15, Lemma 8.2] by Lemma 6.1, with the observation that, by the WFP, we have  $\mathbf{d}^{-1}(\mathbf{1}_Q) = \Lambda^{-1}$  (Remark 1.8(1)).

Let  $\overline{\mathbf{d}}: \mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G}) \to Q$  be the cocycle defined in Lemma 6.2, and let us define

$$\mathcal{K}(\Lambda \Join^{\varphi} \mathcal{G}) := (\overline{\mathbf{d}})^{-1}(\mathbf{1}_G) = \{ [\tau^{(\alpha,g)} \sigma^{(\beta,f)}, F \Join^{\varphi} \mathcal{G}] \in \mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G}) : \mathbf{d}(\alpha) \mathbf{d}(\beta)^{-1} = \mathbf{1}_G \},$$

which is an open subgroupoid of  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$ .

In order to be able to decompose the groupoid  $\mathcal{K}(\Lambda \Join^{\varphi} \mathcal{G})$  as a union of more treatable groupoids, we need to impose some conditions on the semigroup  $\Gamma$ .

**Definition 6.3.** Let  $\Gamma \subseteq Q$  be a subsemigroup of a group Q with  $\Gamma \cap \Gamma^{-1} = \mathbf{1}_Q$ . We say that  $\Gamma$  is a *join-semilattice* if given  $g_1, g_2 \in \Gamma$ 

$$\inf\{g \in \Gamma : g_1, g_2 \le g\}$$

exists and is unique. We will denote it by  $g_1 \vee g_2$ .

**Remark 6.4.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP, and assume that  $\Gamma$  is a join-semilattice. Then, given  $\alpha, \beta$  with  $\alpha \cap \beta$ , we have that  $\mathbf{d}(\gamma) = \mathbf{d}(\alpha) \lor \mathbf{d}(\beta)$  for every  $\gamma \in \alpha \lor \beta$ . Indeed, let  $\gamma \in \alpha \lor \beta$ . Since  $\alpha, \beta \leq \gamma$ , then  $\mathbf{d}(\alpha), \mathbf{d}(\beta) \leq \mathbf{d}(\gamma)$ , so  $\mathbf{d}(\alpha) \lor \mathbf{d}(\beta) \leq \mathbf{d}(\gamma)$ . By the WFP, there exist  $\gamma_1, \gamma_2 \in \Lambda$  such that  $\gamma = \gamma_1 \gamma_2$  with  $\mathbf{d}(\gamma_1) = \mathbf{d}(\alpha) \lor \mathbf{d}(\beta)$ . Now,  $\mathbf{d}(\alpha), \mathbf{d}(\beta) \leq \mathbf{d}(\gamma_1)$ , and so we have that  $\alpha, \beta \leq \gamma_1 \leq \gamma$  by Lemma 6.1. But since  $\gamma$  is a minimal extension of  $\alpha$  and  $\beta$ , it follows that  $\gamma \approx \gamma_1$ , so  $\mathbf{d}(\gamma) = \mathbf{d}(\gamma_1) = \mathbf{d}(\alpha) \lor \mathbf{d}(\beta)$ .

We now assume that  $\Gamma$  is a join-semilattice. Then, given  $g \in \Gamma$ , we define

$$\mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G}) := \{ [\tau^{(\alpha,h)} \sigma^{(\beta,f)}, F \Join^{\varphi} \mathcal{G}] : \mathbf{d}(\alpha) = \mathbf{d}(\beta) \le g \}$$

We claim that  $\mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$  is an open subgroupoid of  $\mathcal{K}(\Lambda \Join^{\varphi} \mathcal{G})$ . Since

$$\mathcal{K}_g(\Lambda \bowtie^{\varphi} \mathcal{G}) = \bigcup_{\mathbf{d}(\alpha) = \mathbf{d}(\beta) \le g} \Theta(\tau^{(\alpha,h)} \sigma^{(\beta,f)}, \operatorname{dom}(\tau^{(\alpha,h)} \sigma^{(\beta,f)})),$$

we have that  $\mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$  is an open subgroupoid. Let  $[\tau^{(\alpha,h)}\sigma^{(\beta,f)}, F \Join^{\varphi} \mathcal{G}], [\tau^{(\delta,k)}\sigma^{(\eta,l)}, F' \Join^{\varphi} \mathcal{G}] \in \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$  two composable elements with  $g_1 := \mathbf{d}(\beta) = \mathbf{d}(\alpha) \leq g$  and  $g_2 :=$ 

 $\mathbf{d}(\delta) = \mathbf{d}(\eta) \leq g$ . Since  $\beta, \delta \in F$ , there exists  $\varepsilon \in (\beta \lor \delta) \cap F$ , and  $\mathbf{d}(\varepsilon) = \mathbf{d}(\alpha) \lor \mathbf{d}(\beta) = g_1 \lor g_2 \leq g$  (Remark 6.4). Then,

$$[\tau^{(\alpha,h)}\sigma^{(\beta,f)}, F] = [\tau^{(\alpha,hf^{-1})}\sigma^{(\beta,s(f))}, F]$$
  
=  $[\tau^{(\alpha,hf^{-1})}\sigma^{(\beta,s(f))}\tau^{(\varepsilon,s(\varepsilon))}\sigma^{(\varepsilon,s(\varepsilon))}, F]$   
=  $[\tau^{(\alpha(hf^{-1}\cdot\sigma^{\beta}(\varepsilon)),\varphi(\sigma^{\beta}(\varepsilon),hf^{-1}))}\sigma^{(\varepsilon,s(f))}, F]$ 

and

$$\begin{aligned} [\tau^{(\delta,k)}\sigma^{(\eta,l)}, F'] &= [\tau^{(\delta,r(k))}\sigma^{(\eta,lk^{-1})}, F'] \\ &= [\tau^{(\varepsilon,s(\varepsilon))}\sigma^{(\varepsilon,s(\varepsilon))}\tau^{(\delta,r(k))}\sigma^{(\eta,lk^{-1})}, F'] \\ &= [\tau^{(\varepsilon,s(\varepsilon))}\sigma^{(\sigma^{\delta}(\varepsilon)\eta,lk^{-1})}, F] \end{aligned}$$

while the product give us

$$\begin{split} [\tau^{(\alpha(hf^{-1}\cdot\sigma^{\beta}(\varepsilon)),\varphi(\sigma^{\beta}(\varepsilon),hf^{-1}))}\sigma^{(\varepsilon,s(f))},F][\tau^{(\varepsilon,s(\varepsilon))}\sigma^{(\sigma^{\delta}(\varepsilon)\eta,lk^{-1})},F] = \\ &= [\tau^{(\alpha(hf^{-1}\cdot\sigma^{\beta}(\varepsilon)),\varphi(\sigma^{\beta}(\varepsilon),hf^{-1}))}\sigma^{(\sigma^{\delta}(\varepsilon)\eta,lk^{-1})},F'] \end{split}$$

But

$$\begin{split} \mathbf{d}(\alpha(hf^{-1}\cdot\sigma^{\beta}(\varepsilon))) &= \mathbf{d}(\alpha)\mathbf{d}(hf^{-1}\cdot\sigma^{\beta}(\varepsilon)) = \mathbf{d}(\alpha)\mathbf{d}(\sigma^{\beta}(\varepsilon) \\ &= \mathbf{d}(\alpha)\mathbf{d}(\beta)^{-1}\mathbf{d}(\varepsilon) = \mathbf{d}(\alpha)\mathbf{d}(\alpha)^{-1}\mathbf{d}(\varepsilon) = \mathbf{d}(\varepsilon) = g_{1}\vee g_{2} \end{split}$$

and

$$\mathbf{d}(\sigma^{\delta}(\varepsilon)\eta) = \mathbf{d}(\varepsilon)\mathbf{d}(\delta)^{-1}\mathbf{d}(\eta) = \mathbf{d}(\varepsilon)\mathbf{d}(\eta)^{-1}\mathbf{d}(\eta) = \mathbf{d}(\varepsilon) = g_1 \vee g_2.$$

Therefore,  $[\tau^{(\alpha,h)}\sigma^{(\beta,f)}, F][\tau^{(\delta,k)}\sigma^{(\eta,l)}, F'] \in \mathcal{K}_{g_1 \vee g_2}(\Lambda \Join^{\varphi} \mathcal{G}) \subseteq \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$ , as desired.

Moreover, as a consequence of the above computation, given  $g_1, g_2 \leq g$  we have that  $\mathcal{K}_{g_1}(\Lambda \Join^{\varphi} \mathcal{G})\mathcal{K}_{g_2}(\Lambda \Join^{\varphi} \mathcal{G}) \subseteq \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$ . Then, if  $\Gamma$  is countable, there exists an ascending sequence of elements  $g_1, g_2, \ldots \in \Gamma$  such that for every  $g \in \Gamma$  there exists  $n \in \mathbb{N}$  with  $g \leq g_n$ . Hence,  $\mathcal{K}(\Lambda \Join^{\varphi} \mathcal{G}) = \bigcup_{i=1}^{\infty} \mathcal{K}_{g_i}(\Lambda \Join^{\varphi} \mathcal{G})$ .

The next step will be to define a cocycle of the groupoids  $\mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$  onto  $\Lambda^{-1} \Join^{\varphi} \mathcal{G}$ . In order to do that, we will need to make the following assumption.

**Definition 6.5.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP. We will say that  $\Lambda$  satisfies property  $(\bigstar)$  if given  $F \in \Lambda_{tight}$  and  $g \in \Gamma$ , then there exists  $\beta_g \in F$  (non-necessarily unique) with  $\mathbf{d}(\beta_g) \leq g$  such that, whenever  $\alpha \in F$  satisfies  $\mathbf{d}(\alpha) \leq g$ , we have that  $\alpha \leq \beta$ .

**Remark 6.6.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP and property  $(\bigstar)$ .

- (1) Let  $F \in \Lambda_{tight}$ , and let  $g \in \Gamma$  and let  $\beta_g \in \Lambda$  satisfying the conditions of Definition 6.5. Suppose that there exists another  $\beta'_g$  satisfying the same properties than  $\beta_g$ . Then,  $\mathbf{d}(\beta_g) = \mathbf{d}(\beta'_g)$ , and hence by Lemma 6.1 we have that  $\beta_g \approx \beta'_g$ . Thus,  $\beta_g$  is unique up to an invertible.
- (2) Let  $F \in \Lambda_{tight}$ , and let  $g \in \Gamma$  and let  $\beta_g \in \Lambda$  satisfying the conditions of Definition 6.5. Now, let  $\alpha \in \Lambda$  such that  $s(\beta_g) = s(\alpha)$  and  $\mathbf{d}(\beta_g) = \mathbf{d}(\alpha)$ . Recall that

$$F' := \tau^{\alpha} \sigma^{\beta_g} \cdot F = \bigcup_{\beta_g \le \gamma, \, \gamma \in F} [\alpha \sigma^{\beta_g}(\gamma)] \,.$$

Let  $\beta'_g \in F'$  satisfying the conditions of Definition 6.5. Then,  $\alpha \leq \beta'_g$ . On the other hand, there exists  $\gamma \in F$  such that  $\alpha \sigma^{\alpha}(\beta'_g) = \beta'_g \leq \alpha \sigma^{\beta_g}(\gamma)$ , whence by left cancellation  $\sigma^{\alpha}(\beta'_g) \leq \sigma^{\beta_g}(\gamma)$ , and  $\beta_g \sigma^{\alpha}(\beta'_g) \leq \beta_g \sigma^{\beta_g}(\gamma) = \gamma$ . Thus,  $\beta_g \sigma^{\alpha}(\beta'_g) \in F$  and  $\mathbf{d}(\beta_g \sigma^{\alpha}(\beta'_g)) = \mathbf{d}(\beta'_g) \leq g$ . Then, by property  $(\bigstar)$  we have that  $\beta_g \sigma^{\alpha}(\beta'_g) \leq \beta_g$ , whence by left cancellation  $\sigma^{\alpha}(\beta'_g)$  must be an invertible. Thus,  $\beta'_g \approx \alpha$ .

**Proposition 6.7** (c.f.[15, Lemma 8.8]). Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP, and assume every bounded ascending sequence of elements of  $\Gamma$  stabilizes. Then  $\Lambda$  satisfies property  $(\bigstar)$ .

Given a LCSC  $\Lambda$ , a discrete groupoid  $\mathcal{G}$  acting on  $\Lambda$  and a category system  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$ , by Lemma 3.11 we have that  $(\Lambda \Join^{\varphi} \mathcal{G})^{-1} = \Lambda^{-1} \Join^{\varphi} \mathcal{G}$ . Thus,  $\Lambda^{-1} \Join^{\varphi} \mathcal{G}$  is a discrete groupoid.

Before proving the connection between amenability of both  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  and  $\mathcal{G}_{tight}(\Lambda)$ , we need a key technical result.

**Proposition 6.8.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP, let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a pseudo-free category system, let  $\Lambda \Join^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product, and suppose that  $\Lambda$  satisfies property  $(\bigstar)$ . Then, for every  $g \in \Gamma$ , there exists a continuous groupoid homomorphism

$$\mathbf{t}^{(g)}: \mathcal{K}_q(\Lambda \Join^{\varphi} \mathcal{G}) \to \Lambda^{-1} \Join^{\varphi} \mathcal{G}.$$

*Proof.* Fix  $g \in \Gamma$ , and for every  $F \in \Lambda_{tight}$  choose  $\beta_F$  satisfying property  $(\bigstar)$ . Let  $[\tau^{(\alpha,f)}\sigma^{(\gamma,s(f))}, F] \in \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$ . Then,  $\mathbf{d}(\alpha) = \mathbf{d}(\gamma) \leq g$ , and hence  $\gamma \leq \beta_F$ . Therefore,

$$[\tau^{(\alpha,f)}\sigma^{(\gamma,s(f))},F] = [\tau^{(\alpha,f)}\sigma^{(\gamma,s(f))}\tau^{(\beta_F,s(\beta_F))}\sigma^{(\beta_F,s(\beta_F))},F]$$
$$= [\tau^{(\alpha(f\cdot\sigma^{\gamma}(\beta_F)),\varphi(f,\sigma^{\gamma}(\beta_F)))}\sigma^{(\beta_F,s(\beta_F))},F].$$

By Remark 6.6 we have that  $\alpha(f \cdot \sigma^{\gamma}(\beta_F)) = \beta_{F'}\xi$ , where  $F' := \tau^{(\alpha,f)}\sigma^{(\gamma,s(f))} \cdot F$  and  $\xi \in \Lambda^{-1}$ . So,

$$[\tau^{(\alpha,f)}\sigma^{(\gamma,s(f))},F] = [\tau^{(\beta_{F'}\xi,\varphi(f,\sigma^{\gamma}(\beta_F)))}\sigma^{(\beta_F,s(\beta_F))},F]$$

Therefore, every element in  $\mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$  is of the form  $[\tau^{(\beta_{F'}\xi,h)}\sigma^{(\beta_F,s(\beta_F))}, F]$  for some  $\xi \in \Lambda^{-1}$  and  $h \in \mathcal{G}$ , and then we define

$$\mathbf{t}^{(g)}([\tau^{(\beta_{F'}\xi,h)}\sigma^{(\beta_F,s(\beta_F))},F]) = (\xi,h)$$

Let us check that  $\mathbf{t}^{(g)}$  is well defined. To this end, let  $[\tau^{(\beta_{F'}\xi_1,h_1)}\sigma^{(\beta_F,s(\beta_F))},F]$  and  $[\tau^{(\beta_{F''}\xi_2,h_2)}\sigma^{(\beta_F,s(\beta_F))},F]$  in  $\mathcal{K}_q(\Lambda \bowtie^{\varphi} \mathcal{G})$  with

$$[\tau^{(\beta_{F'}\xi_1,h_1)}\sigma^{(\beta_F,s(\beta_F))},F] = [\tau^{(\beta_{F''}\xi_2,h_2)}\sigma^{(\beta_F,s(\beta_F))},F].$$

First observe that since the germ of  $\tau^{(\beta_{F'}\xi_1,h_1)}\sigma^{(\beta_F,s(\beta_F))}$  and  $\tau^{(\beta_{F''}\xi_2,h_2)}\sigma^{(\beta_F,s(\beta_F))}$  on F is the same, this means that the image of F by these maps are the same, so F' = F''. Moreover there exists  $\gamma \in F$  with  $\beta_F \leq \gamma$  such that

$$(\tau^{(\beta_{F'}\xi_1,h_1)}\sigma^{(\beta_F,s(\beta_F))})(\tau^{(\gamma,s(\gamma))}\sigma^{(\gamma,s(\gamma))})$$
  
=  $\tau^{(\beta_{F'}\xi_1(h_1\cdot\sigma^{\beta_F}(\gamma)),\varphi(h_1,\sigma^{\beta_F}(\gamma)))}\sigma^{(\gamma,s(\gamma))}$   
=  $(\tau^{(\beta_{F'}\xi_2,h_2)}\sigma^{(\beta_F,s(\beta_F))})(\tau^{(\gamma,s(\gamma))}\sigma^{(\gamma,s(\gamma))})$ 

$$=\tau^{(\beta_{F'}\xi_2(h_2\cdot\sigma^{\beta_F}(\gamma)),\varphi(h_2,\sigma^{\beta_F}(\gamma)))}\sigma^{(\gamma,s(\gamma))}.$$

Therefore,

$$\beta_{F'}\xi_1(h_1 \cdot \sigma^{\beta_F}(\gamma)) = \beta_{F'}\xi_2(h_2 \cdot \sigma^{\beta_F}(\gamma)) \quad \text{and} \quad \varphi(h_1, \sigma^{\beta_F}(\gamma)) = \varphi(h_2, \sigma^{\beta_F}(\gamma)).$$
  
In particular, by left cancellation we have that

$$\xi_1(h_1 \cdot \sigma^{\beta_F}(\gamma)) = \xi_2(h_2 \cdot \sigma^{\beta_F}(\gamma)),$$

and

$$\begin{aligned} \xi_2^{-1}\xi_1(h_1 \cdot \sigma^{\beta_F}(\gamma)) &= h_2 \cdot \sigma^{\beta_F}(\gamma) \,, \\ h_2^{-1} \cdot (\xi_2^{-1}\xi_1(h_1 \cdot \sigma^{\beta_F}(\gamma))) &= \sigma^{\beta_F}(\gamma) \,, \\ (h_2^{-1} \cdot \xi_2^{-1}\xi_1)(\varphi(h_2^{-1}, \xi_2^{-1}\xi_1)h_1 \cdot \sigma^{\beta_F}(\gamma))) &= \sigma^{\beta_F}(\gamma) \,, \\ \varphi(h_2^{-1}, \xi_2^{-1}\xi_1)h_1 \cdot \sigma^{\beta_F}(\gamma)) &= (h_2^{-1} \cdot \xi_2^{-1}\xi_1)^{-1}\sigma^{\beta_F}(\gamma) \,. \end{aligned}$$

On the other hand, we have that

$$s(\gamma) = \varphi(h_2, \sigma^{\beta_F}(\gamma))^{-1} \varphi(h_1, \sigma^{\beta_F}(\gamma)) = \varphi(h_2^{-1}, h_2 \cdot \sigma^{\beta_F}(\gamma)) \varphi(h_1, \sigma^{\beta_F}(\gamma))$$
  
$$= \varphi(h_2^{-1}, \xi_2^{-1} \xi_1(h_1 \cdot \sigma^{\beta_F}(\gamma))) \varphi(h_1, \sigma^{\beta_F}(\gamma))$$
  
$$= \varphi(\varphi(h_2^{-1}, \xi_2^{-1} \xi_1), h_1 \cdot \sigma^{\beta_F}(\gamma)) \varphi(h_1, \sigma^{\beta_F}(\gamma))$$
  
$$= \varphi(\varphi(h_2^{-1}, \xi_2^{-1} \xi_1) h_1, \sigma^{\beta_F}(\gamma)).$$

Since the system is pseudo-free, we have that

$$\varphi(h_2^{-1}, \xi_2^{-1}\xi_1)h_1 = s(h_1)$$
 and  $(h_2^{-1} \cdot \xi_2^{-1}\xi_1)^{-1} = s(\beta_F)$ .

From the second equality we deduce that  $\xi_2^{-1}\xi_1 = s(\beta_F)$ , and hence  $\xi_1 = \xi_2$ . Thus,

$$\varphi(h_2^{-1},\xi_2^{-1}\xi_1)h_1 = \varphi(h_2^{-1},s(\xi_1)h_1 = h_2^{-1}h_1 = s(h_1),$$

and so  $h_2 = h_1$ . Hence,  $\mathbf{t}^{(g)}$  is a well-defined map, as desired.

Now, two composable elements  $(x, y) \in \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})^{(2)}$  are of the form

$$x = [\tau^{(\beta_{F'}, \xi_1, h_1)} \sigma^{(\beta_{F'}, s(\beta_{F'}))}, F'] \quad \text{and} \quad y = [\tau^{(\beta_{F'}, \xi_2, h_2)} \sigma^{(\beta_I, s(\beta_F))}, F],$$

where  $\xi_1, \xi_2 \in \Lambda^{-1}, h_1, h_2 \in \mathcal{G}, F \in \Lambda_{tight}, F' := \tau^{(\beta_{F'}\xi_2, h_2)}\sigma^{(\beta_F, s(\beta_F))} \cdot F$  and  $F'' := \tau^{(\beta_{F'}\xi_1, h_1)}\sigma^{(\beta_{F'}, s(\beta_{F'}))} \cdot F'$ . Since

$$xy = [\tau^{(\xi_1(h_1 \cdot \xi_2), \varphi(h_1, \xi_2)h_2)} \sigma^{(\beta_F, s(\beta_F))}, F],$$

we have that

$$\mathbf{t}^{(g)}(xy) = (\xi_1(h_1 \cdot \xi_2), \varphi(h_1, \xi_2)h_2) = (\xi_1, h_1)(\xi_2, h_2) = \mathbf{t}^{(g)}(x)\mathbf{t}^{(g)}(y) \,.$$

Thus,  $\mathbf{t}^{(g)}$  is a groupoid homomorphism. Finally, given any  $x = (\xi, h) \in \Lambda^{-1} \Join^{\varphi} \mathcal{G}$  we have that

$$(\mathbf{t}^{(g)}(\xi,h))^{-1}(x) = \{ [\tau^{(\beta_{F'}\xi,h)}\sigma^{(\beta_{F},s(\beta_{F}))},F] : F \in \Lambda_{tight} \}$$
$$= \bigcup_{F \in \Lambda_{tight}, s(\beta_{F})=s(h)} \{ [\tau^{(\beta_{F'}\xi,h)}\sigma^{(\beta_{F},s(\beta_{F}))},G] : G \in \Lambda_{tight} \text{ and } \beta_{F} \in G \},$$

that is a union of open sets of  $\mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})$ , so  $\mathbf{t}^{(g)}$  is continuous.

Given two groupoids  $\mathcal{G}$  and  $\mathcal{H}$  a groupoid homomorphism  $p: \mathcal{G} \to \mathcal{H}$  is called *strongly* surjective if p is surjective and for every  $x \in \mathcal{G}^{(0)}$  we have that  $p(r^{-1}(x)) = r^{-1}(p(x))$ (see [1, Definition 5.2.7]).

In general the map  $\mathbf{t}^{(g)} : \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G}) \to \Lambda^{-1} \Join^{\varphi} \mathcal{G}$  defined in Proposition 6.8 is not strongly surjective. However, we can consider the subgroupoid

$$\mathcal{H}_g := \mathbf{t}^{(g)}(\mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})) =$$

 $\{(\xi,g) \in \Lambda^{-1} \Join^{\varphi} \mathcal{G} : \exists F, F' \in \Lambda_{tight}, \, s(\beta_F) = d(\phi(g)), \, r(\xi) = s(\beta_{F'})\}.$ Let  $F' \in \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G})^{(0)}$  (here we identify  $\mathcal{K}_g(\Lambda \bowtie^{\varphi} \mathcal{G})^{(0)}$  with  $\Lambda_{tight}$ ), then

$$\mathbf{t}^{(g)}(r^{-1}(F')) =$$

$$\mathbf{t}^{(g)}(\{[\tau^{(\beta_{F'}\xi,h)}\sigma^{(\beta_{F},s(\beta_{F}))},F]:r(\xi)=s(\beta_{F'}), \exists F \in \Lambda_{tight} \text{ with } s(\beta_{F})=s(g)\}) = \{(\xi,g) \in \Lambda^{-1} \Join^{\varphi} \mathcal{G}: r(\xi)=s(\beta_{F'}), \exists F \in \Lambda_{tight} \text{ with } s(\beta_{F})=s(g)\}$$

and

$$r^{-1}(\mathbf{t}^{(g)}(F')) \cap \mathcal{H}_g = r^{-1}(s(\beta_{F'}), s(\beta_{F'})) \cap \mathcal{H}_g = \{(\xi, g) \in \Lambda^{-1} \Join^{\varphi} \mathcal{G} : r(\xi) = s(\beta_{F'})\} \cap \mathcal{H}_g$$
$$= \{(\xi, g) \in \Lambda^{-1} \bowtie^{\varphi} \mathcal{G} : r(\xi) = s(\beta_{F'}), \exists F \in \Lambda_{tight} \text{ with } s(\beta_F) = s(g)\}.$$

Therefore the map  $\mathbf{t}^{(g)} : \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G}) \to \mathcal{H}_g$  is strongly surjective.

Now, we are ready to prove the main result in this Section:

**Proposition 6.9.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the WFP, let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a pseudo-free category system, let  $\Lambda \bowtie^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product, and suppose that  $\Lambda$  satisfies property  $(\bigstar)$ . Suppose that the groupoid  $\Lambda^{-1} \bowtie^{\varphi} \mathcal{G}$  and the group Q are amenable. Moreover, assume that  $\Gamma$  is a join-semilattice. Then the following statements are equivalent:

- (1)  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is amenable,
- (2) the kernel of the map  $\overline{\mathbf{d}} : \mathcal{G}_{tight}(\Lambda) \to Q$  is amenable,
- (3)  $\mathcal{G}_{tight}(\Lambda)$  is amenable.

*Proof.* (2) and (3) are equivalent due to [16, Corollary 4.5] and that ker  $\overline{\mathbf{d}}$  is an open subgroupoid of  $\mathcal{G}_{tight}(\Lambda)$ . That (1) implies (3) is because  $\mathcal{G}_{tight}(\Lambda)$  is an open subgroupoid of  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G})$ . So, it is enough to prove that (2) implies (1).

Let  $\overline{\mathbf{t}} : \mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G}) \to Q$  be the cocycle defined in Lemma 6.2. By [16, Corollary 4.5], it is enough to prove that  $\overline{\mathbf{d}}^{-1}(\mathbf{1}_Q) = \mathcal{K}(\Lambda \Join^{\varphi} \mathcal{G})$  is amenable. Moreover, since  $\mathcal{K}(\Lambda \bowtie^{\varphi} \mathcal{G}) = \bigcup_{g \in \Gamma} \mathcal{K}_g(\Lambda \bowtie^{\varphi} \mathcal{G})$ , we have that  $\mathcal{K}(\Lambda \bowtie^{\varphi} \mathcal{G})$  is amenable if  $\mathcal{K}_g(\Lambda \bowtie^{\varphi} \mathcal{G})$  is amenable for every  $g \in \Gamma$  [1, Section 5.2(c)]. Now, let  $\mathbf{t}^{(g)} : \mathcal{K}_g(\Lambda \bowtie^{\varphi} \mathcal{G}) \to \Lambda^{-1} \bowtie^{\varphi} \mathcal{G}$  defined in Proposition 6.8. By assumption  $\Lambda^{-1} \bowtie^{\varphi} \mathcal{G}$  is amenable, and thus  $\mathcal{H}_g := \mathbf{t}^{(g)}(\mathcal{K}_g(\Lambda \bowtie^{\varphi} \mathcal{G})) \subseteq \Lambda^{-1} \bowtie^{\varphi} \mathcal{G}$  is amenable and the map  $\mathbf{t}^{(g)} : \mathcal{K}_g(\Lambda \bowtie^{\varphi} \mathcal{G}) \to \mathcal{H}_g$  is strongly surjective (see the comments after Proposition 6.8). Then, by [1, Theorem 5.2.14],  $\mathcal{K}_g(\Lambda \bowtie^{\varphi} \mathcal{G})$  is amenable if ker  $\mathbf{t}^{(g)}$  is amenable. But observe that, if we identify  $\mathcal{G}_{tight}(\Lambda)$  with  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G}^{(0)})$ , then we have that

$$\ker \mathbf{t}^{(g)} = \mathcal{K}_g(\Lambda \Join^{\varphi} \mathcal{G}) \cap \mathcal{G}_{tight}(\Lambda) \subseteq \ker \mathbf{d} \cap \mathcal{G}_{tight}(\Lambda) + \mathcal{G}_{tight}(\Lambda) +$$

so ker  $\mathbf{t}^{(g)}$  is an open subgroupoid of ker  $\overline{\mathbf{d}}$ . Thus, ker  $\mathbf{t}^{(g)}$  is amenable by hypothesis.  $\Box$ 

With the above notation observe that if  $\Lambda^{-1} = \Lambda^0$ , then  $\Lambda^{-1} \Join^{\varphi} \mathcal{G} \cong \mathcal{G}$ .

**Corollary 6.10.** Let  $\Lambda$  be a LCSC with length function  $\mathbf{d} : \Lambda \to \Gamma$  satisfying the UFP, let  $\mathcal{G}$  be a discrete groupoid acting on  $\Lambda$ , let  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  be a pseudo-free category system, let  $\Lambda \bowtie^{\varphi} \mathcal{G}$  be the associated Zappa-Szép product, and suppose that  $\Lambda$  satisfies property  $(\bigstar)$ . Moreover, assume that  $\Gamma$  is a join-semilattice. Suppose that the groupoid  $\mathcal{G}$  and the group Q are amenable. Then  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G})$  is an amenable groupoid.

*Proof.* First observe that, since  $\mathbf{d} : \Lambda \to \Gamma$  has the UFP,  $\Lambda$  has no inverses. So,  $\Lambda^{-1} \Join^{\varphi} \mathcal{G}$  is isomorphic to  $\mathcal{G}$ . Then, by Proposition 6.9, it is enough to prove that the kernel of the map  $\overline{\mathbf{d}} : \mathcal{G}_{tight}(\Lambda) \to Q$  is amenable. But this was shown in [15, Section 8].  $\Box$ 

**Example 6.11.** Let  $\Lambda$  be the category with objects  $\{v_i\}_{i\in\mathbb{Z}}$  and freely generated by the morphisms  $\{\alpha_i\}_{i\in\mathbb{Z}}, \{\gamma_i\}_{i\in\mathbb{Z}}$  and  $\{\gamma_i^{-1}\}_{i\in\mathbb{Z}}$ , such that

$$s(\alpha_i) = v_i \quad \text{and} \quad r(\alpha_i) = v_{i+1},$$
  

$$s(\gamma_i) = v_i \quad \text{and} \quad r(\gamma_i) = v_i,$$
  

$$s(\gamma_i^{-1}) = v_i \quad \text{and} \quad r(\gamma_i^{-1}) = v_i,$$

for every  $i \in \mathbb{Z}$ , modulo the relation

$$\gamma_i \gamma_i^{-1} = \gamma_i^{-1} \gamma_i = v_i$$

for every  $i \in \mathbb{Z}$ . A is a left and right cancellative small category. We can define the length function  $\mathbf{d} : \Lambda \to \mathbb{N}$  given by  $\mathbf{d}(\alpha_i) = 1$  and  $\mathbf{d}(\gamma_i) = \mathbf{d}(\gamma_i^{-1}) = 0$  for every  $i \in \mathbb{Z}$ . Then  $\mathbf{d}$  satisfies the WFP and  $\Lambda^{-1}$  is generated by  $\{\gamma_i, \gamma_i^{-1}\}_{i\in\mathbb{Z}}$ . Now we define the groupoid  $\mathcal{G}$  with unit space  $\mathcal{G}^{(0)} = \{v_i\}_{i\in\mathbb{Z}}$  and generated by  $\{g_i\}_{i\in\mathbb{Z}}$  with  $s(g_i) = v_i$  and  $r(g_i) = v_{i-1}$ . We define  $\phi : \mathcal{G} \to \operatorname{PIso}(\Lambda, \mathbf{d})$  such that  $\phi(g_i) : v_i\Lambda \to v_{i-1}\Lambda$  is such that it translates the path one position to the left. Observe that then

$$\phi(g_i)|_{\gamma_i} = \phi(g_i)$$
 and  $\phi(g_i)|_{\alpha_{i-1}} = \phi(g_{i-1})$ 

for every  $i \in \mathbb{Z}$ . Therefore, the action of  $\mathcal{G}$  on  $\Lambda$  is self-similar, and we define the cocyle  $\varphi : \mathcal{G}_s \times_r \Lambda \to \mathcal{G}$  by  $\varphi(g_i, \gamma_i) := g_i$  and  $\varphi(g_i, \alpha_{i-1}) := g_{i-1}$ . Observe also that  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is a pseudo-free category system, and hence  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is a Hausdorff groupoid by Corollary 5.11.

We will check that the groupoid  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G})$  is topologically free and minimal. Let  $\beta_1, \beta_2 \in \Lambda$  with  $r(\beta_1) = r(\beta_2)$ , let  $a_1, a_2 \in \mathcal{G}$  such that  $r(a_1) = s(\beta_1) = v_k$ ,  $r(a_2) = s(\beta_2) = v_l$  and  $s(a_1) = s(a_2) = v_j$ , and assume that  $\beta_1(a_1 \cdot \delta) \cap \beta_2(a_2 \cdot \delta)$  for every  $\delta \in v_j \Lambda$ . We claim that then  $\beta_1 = \beta_2$ . Indeed, first observe that  $\beta_1(a_1 \cdot v_j) \cap \beta_2(a_2 \cdot v_j)$ , so  $\beta_1 \cap \beta_2$ . But this mean that either  $\beta_1 \leq \beta_2$  or  $\beta_2 \leq \beta_1$ . Suppose that  $\beta_1 \leq \beta_2$ , so that there exists  $\gamma \in v_k \Lambda$  such that  $\beta_1 \gamma = \beta_2$ . But, by hypothesis,  $\beta_1(a_1 \cdot \delta) \cap \beta_1 \gamma(a_2 \cdot \delta)$  for every  $\delta \in v_j \Lambda$ . Thus,  $\beta_1(a_1 \cdot \delta) \leq \beta_1 \gamma(a_2 \cdot \delta)$  for every  $\delta \in v_j \Lambda$ . But this forces  $\gamma = v_k$ , and hence  $\beta_1 = \beta_2$ .

Now, since  $\beta_1 = \beta_2$ , we have that  $a_1 = a_2$ , and therefore the set  $F = \{v_j\}$  satisfies the conditions of Proposition 5.12(3). So,  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is topologically free.

To check minimality take  $\beta_1, \beta_2 \in \Lambda$  and let  $F = \{r(\beta_2)\}$ . Now, let  $g \in \mathcal{G}$  be the unique element such that  $s(g) = r(\beta_2)$  and  $r(g) = s(\beta_1)$ . Then, we have that  $s(\beta_1)\Lambda(g \cdot r(\beta_2)) = s(\beta_1)\Lambda s(\beta_1 \neq \emptyset$ . Thus, condition (3) of Proposition 5.13 is satisfied, and hence  $\mathcal{G}_{tight}(\Lambda \bowtie^{\varphi} \mathcal{G})$  is minimal. Now we will show that  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is an amenable groupoid. First we will check that  $\Lambda^{-1} \Join^{\varphi} \mathcal{G}$  is an amenable groupoid. Indeed,

$$\Lambda^{-1} \Join^{\varphi} \mathcal{G} = \left\{ (\gamma_i^n, g) \in \Lambda \Join^{\varphi} \mathcal{G} : i, n \in \mathbb{Z}, r(g) = v_i \right\},\$$

with

$$(\gamma_i^n, g) \cdot (\gamma_i^m, h) = (\gamma_i^{n+m}, gh),$$

for  $n, m \in \mathbb{Z}$ ,  $g, h \in \mathcal{G}$  with  $r(g) = v_i$ ,  $s(g) = v_j$  and  $r(h) = v_j$ . Then, we can define the homomorphism  $c : \Lambda^{-1} \Join^{\varphi} \mathcal{G} \to \mathbb{Z}$  by  $c(\gamma_i^n, g) = n$ , with ker c isomorphic to  $\mathcal{G}$ . Therefore  $\Lambda^{-1} \bowtie^{\varphi} \mathcal{G}$  is amenable.

Now, by Proposition 6.9,  $\mathcal{G}_{tight}(\Lambda \Join^{\varphi} \mathcal{G})$  is amenable if and only if  $\mathcal{G}_{tight}(\Lambda)$  is amenable. To determine amenability of  $\mathcal{G}_{tight}(\Lambda)$ , first observe that  $(\Lambda, \mathbf{d})$  is a Levi category [12, Theorem 3.3] and, since  $\Lambda$  is left cancellative, we have that  $\Lambda$  is the Zappa-Szép product of the free category  $B^*$  generated by a transversal of generators of maximal right principal ideals and the groupoid  $\Lambda^{-1}$  [13, Theorem 5.10]. Thus,  $\Lambda \cong B^* \rtimes \Lambda^{-1}$ . But then  $(B^*, \mathbf{d})$  has the UFP and  $\Lambda^{-1} \cong \bigsqcup_{i \in \mathbb{Z}} \mathbb{Z}$  is an amenable groupoid. Moreover, since  $\Lambda$  is right cancellative, we have that  $(\Lambda, \mathbf{d}, \mathcal{G}, \varphi)$  is a pseudo-free category system by Proposition 3.17. Thus,  $\mathcal{G}_{tight}(\Lambda)$  is amenable by Corollary 6.10.
